The scale of the exploration program has been designed to minimise clearing. Only six drill pads and 2 km of track will be required giving a total of 1.02 ha of clearing. Existing access tracks were to avoid clearing. A flora survey has been conducted within polygons. This provides more flexibility to identify and avoid clearing conservation significant flora (where possible) when planning the location of exploration tracks and pads.
