Purpose of clearing

The Cruising Yacht Club will be putting in a bid to host the 2021 F18 Catamaran world championships in March 2021. The City of Rockingham has received a request to provide a suitable lot space to support the rigging and overnight storage of approximately 80- 100 catamarans to accommodate large events such as those held by the Cruising Yacht Club of WA on the Rockingham foreshore. The current turfed and rigging areas available to the yacht club are congested during large events. The area proposed for clearing is planned to be reinstated with reticulated turf which can be utilised as public open space for recreational purposes within close proximity to the main Rockingham foreshore precinct.
