

City of Rockingham – supporting Information for clearing permit.

The details of a site visit for each proposed clearing location are detailed below. City environmental staff documented flora species occurring at each location.

Proposed clearing area 1: (Adjacent to Powell Road, Baldivis.)

P. Road (between Dog Road and Serpentine Road, Baldivis) and Lot 45 on Survey Diagram P149734.







Species List:

Melaleuca raphiophylla, *Eucalyptus rudis*, *Melaleuca sp*, *Acacia saligna*, *Juncus sp*, *Allocasuarina fraseriana*, *Melaleuca teretiflora*, *Pteridium sp.* over weed species *Kikuyu grass*, *Pelagonium capitatum**, *Lagurus ovatus**, *Avena fatua**, *Schinus terebinthifolius**, *Gomphocarpus fruticosus* and *ficus carica*.

Proposed clearing area 2:

Reserve ID Number 44449 (Lot 1429). San Javier Circle, Secret Harbour. Land is vested in and maintained by the City of Rockingham.





Species List:

Lepidospermum gladiatum, *Alyxia buxifolia*, *Rhagodia baccata*, *Acathocarpus preissii*, *Acacia rostelifera*, *Acacia saligna*, *Cassytha flava*, *Hardenbergia comptoniana*, *Pittosporum ligustrifolium*, *Scaevola crassifolia*, *Callitris preissii* over weed species *Pelagonium capitatum**, *Trachyandra divaricate**, *Kikuyu grass**, Couch grass, *Aventa fatua** and *Opuntia sp.** (Prickly Pear).

Proposed clearing area 3:

Reserve ID Number 45189 (Lot 29) and Lot 55 (Public Access Way) St Claire foreshore reserve. Land is vested in and maintained by the City of Rockingham.





Species List:

Callitris preissii, *Eucalyptus lehmannii*, *Agonis flexuosa*, *Rhagodia baccata*, *Alyxia buxifolia*, *Scaevola crassifolia*, *Diploaena dampieri*, *Acanthocarpus preissii*, *Lepidospermum gladiatum*, *Olearia axillaris*, *Spinifex longifolius*, *Leucophyta brownie*, *Adenanthos sericea*, *Hardenbergia comptoniana* over weed species *Pelagonium capitatum**, *Schinus terebinthifolius** and *Avena fatua**.

Proposed clearing area 4:

Reserve ID Number 27854 (Lot 2055) Hymus Street Reserve. Land is vested in and maintained by the City of Rockingham.

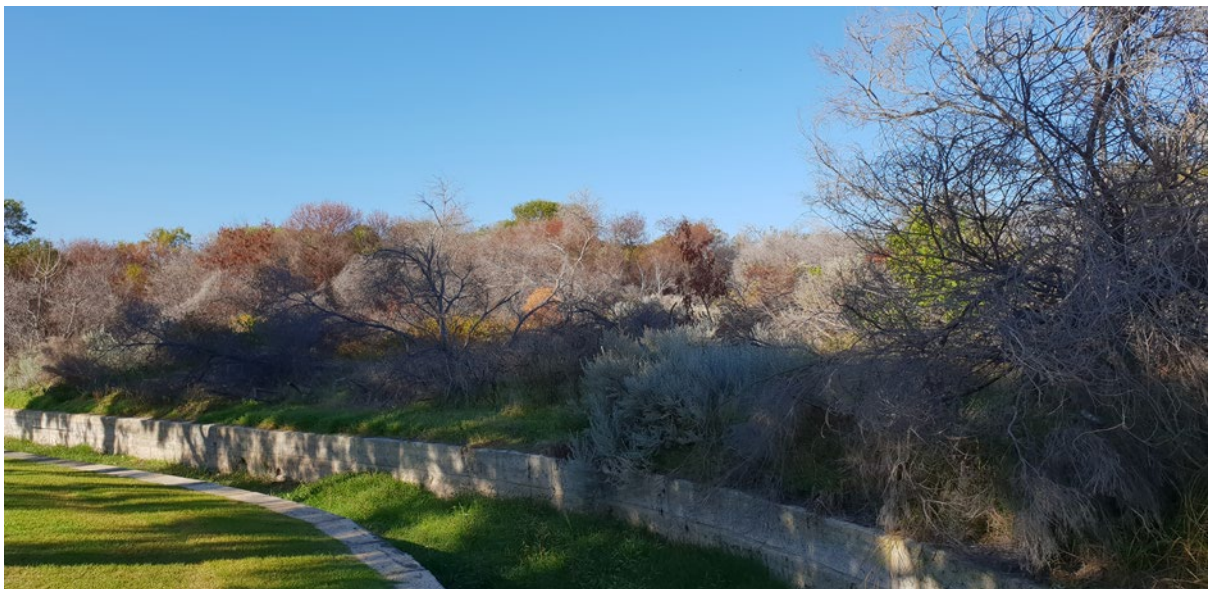
Rhagodia baccata, *Olearia axillaris*, *Acanthocarpus preissii*, *Hardenbergis comptonia*, *Lomandra maritima*, *Acacia rostellifera* over weed species *Schinus terebinthifolius*, *Rhamnus cathartica*, *Euphorbia terracina*, *Pelagonium capitatum*, *Avena fatua* over weed species Couch grass.

Proposed clearing area 5:

Reserve ID Number 47553 (Lot 8006) Bismark reserve. Reserve ID Number 48406 (Lot 5070) Located at the boundary of lake Richmond Nature Reserve. This clearing falls within the external boundary of a TEC occurrence. However the proposed clearing is associated with the maintenance of an existing cleared firebreak to a width of 4 m and was not considered to be a significant impact. Land is vested in and maintained by the City of Rockingham.







Species List:

Xanthorrea preissii, *Acacia rostelifera*, *Olearia axillaris*, *Spyridium globulosum* *Acanthocarpus preissii*, *Melaleuca huegeli*, *Ficinia nodosa*, *Rhagodia baccata*, *Westringia dampieri*, *Eucalyptus sp* and *Grevillea sp.* over weed species *Schinus terebinthifolius**, *Pelagonium capitatum**, Kikuyu grass and African daisy.

Proposed clearing area 6:

P. Road (between Lot 820 and Lot 821 Sixty Eight Rd, Baldvis). City of Rockingham.
