## CLEARING PERMIT

*Granted under section 51E of the Environmental Protection Act 1986*

### AUTHORISED ACTIVITY

Clearing of up to 16.6 hectares of native vegetation within the area cross-hatched yellow in Figure 1 of Schedule 1.

### CONDITIONS

#### 1. Period in which clearing is authorised

The Permit Holder shall not clear any native vegetation after 25 October 2025.

#### 2. Weed control

When undertaking any clearing or other activity authorised under this Permit, the Permit Holder must take the following steps to minimise the risk of the introduction and spread of *weeds*:

- (a) clean earth-moving machinery of soil and vegetation prior to entering and leaving the area to be cleared;
- (b) ensure that no known *weed*-affected soil, *mulch*, *fill* or other material is brought into the area to be cleared; and
- (c) restrict the movement of machines and other vehicles to the limits of the areas to be cleared.

#### 3. Avoid, minimise and reduce the impacts and extent of clearing

In determining the amount of native vegetation to be cleared under this Permit, the Permit Holder must apply the following principles, set out in descending order of preference:

- (a) avoid the clearing of native vegetation;
- (b) minimise the amount of native vegetation to be cleared; and
- (c) reduce the impact of clearing on any environmental value.

#### 4. Offset

The Permit Holder must implement and adhere to the document “*Clearing permit offset proposal form*” (October, 2019), as retained on Department of Mines, Industry Regulation and Safety File No. A1748/201901 as Doc ID 7019968, and “*Edna May Operations Offset Rehabilitation Plan*” (October, 2019), as retained on Department of Mines, Industry Regulation and Safety File No. A1748/201901 as Doc ID 7019967, or future versions as approved by the *CEO*.

## 5. Records to be kept

The permit holder must maintain records relating to the listed relevant matters in accordance with the specifications detailed in Table 1.

**Table 1: Records that must be kept**

1.	In relation to the authorised clearing activities generally	<p>(a) the location where the clearing occurred, recorded using a Global Positioning System (GPS) unit set to Geocentric Datum Australia 1994 (GDA94), expressing the geographical coordinates in Eastings and Northings;</p> <p>(b) the date that the area was cleared;</p> <p>(c) the size of the area cleared (in hectares);</p> <p>(d) actions taken to minimise the risk of the introduction and spread of <i>weeds</i> and in accordance with Condition 2; and</p> <p>(e) actions taken to avoid, minimise, and reduce the impacts and extent of clearing in accordance with Condition 3.</p>
2.	In relation to 'Edna May Operations Offset Rehabilitation Plan' and 'Clearing permit offset proposal form' pursuant to condition 4	<p>(a) a description of the revegetation and rehabilitation activities undertaken;</p> <p>(b) the size of the area revegetated and rehabilitated (in hectares);</p> <p>(c) the date that the area was revegetated and rehabilitated;</p> <p>(d) results of the annual monitoring programme;</p> <p>(e) any remedial actions undertaken; and</p> <p>(f) a description of any other offset activities undertaken.</p>

## 6. Reporting

- (a) The Permit Holder shall provide a report to the *CEO* by 15 May each year for the life of this Permit, demonstrating adherence to all conditions of this Permit, and setting out the records required under Condition 5 of this Permit in relation to clearing carried out between 1 July and 30 June of the previous year.
- (b) If no clearing authorised under this Permit was undertaken between 1 April and 31 March of the previous year, a written report confirming that no clearing under this permit has been carried out, must be provided to the *CEO* by 15 May of each year.
- (c) Prior to 25 October 2038, the Permit Holder must provide to the *CEO* a written report of records required under Condition 5 of this Permit where these records have not already been provided under Condition 6(a) or 6(b) of this Permit.

## DEFINITIONS

In this permit, the terms in Table 2 have the meanings defined.

**Table 2: Definitions**

Term	Definition
CEO	the Chief Executive Officer of the Department responsible for administering the clearing provisions contained within the <i>Environmental Protection Act 1986</i> or an Officer with delegated authority under Section 20 of the <i>Environmental Protection Act 1986</i> .
clearing	has the meaning given under section 3(1) of the EP Act.
condition/s	a condition to which this clearing permit is subject under section 51H of the EP Act.
fill	means material used to increase the ground level, or to fill a depression.

<b>Term</b>	<b>Definition</b>
department	means the department established under section 35 of the <i>Public Sector Management Act 1994</i> (WA) and designated as responsible for the administration of the EP Act, which includes Part V Division 3.
EP Act	<i>Environmental Protection Act 1986</i> (WA)
mulch	means the use of organic matter, wood chips or rocks to slow the movement of water across the soil surface and to reduce evaporation.
native vegetation	has the meaning given under section 3(1) and section 51A of the EP Act.
weed/s	means any plant – <ul style="list-style-type: none"> <li>(a) that is a declared pest under section 22 of the <i>Biosecurity and Agriculture Management Act 2007</i>; or</li> <li>(b) published in a Department of Biodiversity, Conservation and Attractions species-led ecological impact and invasiveness ranking summary, regardless of ranking; or</li> <li>(c) not indigenous to the area concerned.</li> </ul>
