Only trees necessary will be cleared. The extra trees proposed in this application were assessed in previous surveys however were omitted from the clearing figure.</p> <p>The increased clearing results in an additional 0.03ha of clearing from the original 0.179ha. Total clearing is 0.209ha.</p>
