# Application for an amendment to a clearing permit

*Environmental Protection Act 1986, section 51M*

## FORM C4

Clearing of native vegetation is prohibited in Western Australia except where a clearing permit has been granted or an exemption applies. A person who causes or allows unauthorised clearing commits an offence.

The area has been previously disturbed with these areas utilised to minimise additional disturbance.</p> <p>SO4 has consulted with the Traditional Owners and incorporated the outcomes of these consultations in the basis of design and implementation of the Project. The process plant and associated infrastructure have been situated to avoid areas of heritage and cultural significance.</p>
