	<p>If yes, provide details:</p> <p>The southern portion of the Lot 235 supports a significant stand of tuart trees. From the concept design stage, this area was quarantined from the development to ensure this area remained untouched. The access into the site was assessed and the firebreak on the western side of the property provided an entry that required the minimum disruption to flora and fauna.</p> <p>Where possible, minimise clearing and residual impacts on areas of native vegetation and fauna habitat where it:</p> <ul style="list-style-type: none"> • Is representative of a Commonwealth TEC, albeit degraded (2 x Tuart Trees) • Provides foraging habitat for Threatened Black-cockatoos, albeit low quality habitat (Completely Degraded) • Provides fauna habitat <p>Undertake a fauna trapping and translocation program prior to and during clearing events.</p> <p>Maintain the presence of a suitably qualified zoologist on site during clearing, so that any fauna that may be encountered can be relocated to adjacent bushland areas.</p> <p>Ensure suitable drainage features are incorporated into the design to avoid potential adverse impacts from run-off.</p> <p>Ensure suitable drainage features are incorporated into the design to avoid potential flooding.</p> <p>Translocate any grass trees (<i>Xanthorrhoea preissii</i> and <i>Macrozamia redlii</i> palms), on site and use at appropriate landscaping/revegetation sites throughout the City's boundary if they cannot be used directly on site.</p> <p>Utilise appropriate mulched materials for other appropriate landscaping/revegetation sites throughout the City's boundaries.</p>
