Executive summary

Main Roads Western Australia (Main Roads) proposes to extend Mitchell Freeway north from Hester Avenue to Romeo Road, including an upgrade to Wanneroo Road from Dunstan Road to Trian Road (the Proposal).

To facilitate the construction and operation of the Proposal, Main Roads requires to excise various parcels of land from Neerabup National Park and adjacent Neerabup Nature Reserve. Main Roads is consulting and working with Department of Biodiversity Conservation and Attractions Swan Coastal District to progress the excision process.

The Proposal was considered by the Environmental Protection Authority as part of Metropolitan Region Scheme amendment 992/33, which was approved under Ministerial Statement 629; which included the excision of land from the Neerabup National Park and Nature Reserve and addition of land to the "Parks and Recreation" reservation adjacent to the Park.

Main Roads engaged GHD to develop a mitigation strategy for the proposed excisions to Neerabup National Park and Neerabup Nature Reserve required for the proposal.

This mitigation strategy includes excision or addition of a number of small land parcels to enable the Proposal to occur, which covers:

- 8.588 ha from six areas to be excised from Neerabup National Park for the Mitchell Freeway extension and upgrade to Wanneroo Road
- 2.398 ha from one area to be excised from Neerabup Nature Reserve for the upgrade to Wanneroo Road
- 6.735 ha to be added to Neerabup National Park from three areas.

With respect to the areas not previously considered under MRS Amendment 992/33 the following site specific mitigation is proposed:

- Re-instatement of fauna exclusion fencing
- Improved drainage onsite
- Protection of Black Cockatoo trees where practicable.

The following mitigation actions are proposed for the overall Proposal to provide a net benefit for Neerabup National Park and Nature Reserve:

- Installation of fauna exclusion fencing
- Installation of dual use fauna / pedestrian underpass
- Construction of carpark facilities to promote visitor access to the Park and Nature Reserve
- Access to the Yaberoo Budjara Heritage Trail
- Upgrade to access road/s within the National Park
- Landscaping with native plant species
- Weed management
- Interpretative signage.

1. Introduction

1.1 Extension of Mitchell Freeway and upgrade to Wanneroo Road

Main Roads Western Australia (Main Roads) proposes to extend Mitchell Freeway north from Hester Avenue to Romeo Road, including an upgrade to Wanneroo Road from Dunstan Road to Trian Road (the Proposal).

Mitchell Freeway is the main arterial road that connects the northern suburban areas with Perth's central business district. The freeway currently terminates at Hester Avenue. Perth's northern suburbs have experienced continuing strong growth, with the population of Yanchep, Alkimos and Eglinton forecast to reach 118,000 by 2031¹.

The Proposal will extend the Mitchell Freeway a further 5.6 kilometres (km) from Hester Avenue to Romeo Road, as well as upgrading Wanneroo Road to a dual carriageway for 5.5 km from Dunstan Road to Trian Road. The Proposal will improve accessibility, travel times and road safety as well as sustaining jobs and enabling regional development in Perth's northern suburbs.

A portion of the proposed works along Wanneroo Road are currently unfunded and will be included in contract documentation as a priced option (refer to Plate 1), whereby the successful contractor will build this section only if they can do so within the current allowable budget. Any suggested mitigation measures along this section will also be part of the priced option and will only be constructed if funding permits.

1.1.1 Construction works (funded)

The Mitchell Freeway extension works include:

- Constructing a new 5.6 km four lane freeway (two lanes in each direction)
- Completion of northbound on ramp and southbound off ramp at Hester Avenue interchange
- Grade separated interchange at Lukin Drive
- Rail tunnel for the existing rail to exit the freeway median to Butler train station
- Terminate freeway at Romeo Road with an at-grade intersection
- Principal Shared Path on the western side of the freeway
- Romeo Road constructed as dual carriageway with 2 lanes travelling in each direction from Marmion Avenue to Wanneroo Road
- Footpaths/shared paths proposed for Romeo Road
- New/upgraded at-grade intersections at Romeo Road/Wanneroo Road and Romeo Road/Benenden Road.

The Wanneroo Road upgrade works include:

- 1.8 km duplication of Wanneroo Road from south of Romeo Road north to Trian Road
- Improvements to the old Wanneroo Road alignment, currently acting as a service road, including upgrade to the existing Romeo Road/Wanneroo Road intersection.

1.1.2 Construction works (unfunded optional works)

Unfunded optional works include:

- 3.6 km duplication of Wanneroo Road from Dunstan Road to south of Romeo Road
- Improvements to Wanneroo Road/Nowergup Road intersection.




Plate 1 Funded and optional works

1.2 Excision of land from Neerabup National Park

To facilitate the construction and operation of the Proposal, Main Roads requires to excise various parcels of land from Neerabup National Park and adjacent Neerabup Nature Reserve. Main Roads is consulting and working with Department of Biodiversity Conservation and Attractions (DBCA) Swan Coastal District to progress the excision process.

1.2.1 Metropolitan Regionals Scheme Amendment 992/33

The Western Australian Planning Commission (WAPC) initiated a Major Metropolitan Region Scheme (MRS) Amendment 992/33 Clarkson-Butler, which comprised eleven amendments for rezoning and reservation in the north-west corridor of the metropolitan region. Of the eleven amendments, six were considered by the Environmental Protection Authority (EPA) to have the potential to significantly impact on the environment and were assessed pursuant to Section 48A of the *Environmental Protection Act 1986* (EP Act). The six proposed scheme amendments subject to assessment under Section 48A of the EP Act included:

- Adjustments of the existing "Primary Regional Roads" reservation for Wanneroo Road (Proposal 4)
- Reservation of the proposed Mitchell Freeway Transportation Corridor for "Primary Regional Roads" to enable future proposed extensions to the Mitchell Freeway (Proposal 5).

The EPA concluded Proposals 4 and 5 were environmentally acceptable provided the conditions recommended (i.e. to develop and implement environmental management plans) were imposed and enforced. The adjustments to Wanneroo Road (Proposal 4) included excision of 0.68 hectares (ha) from the Neerabup National Park and 1.7 ha of Nowergup Lake Fauna Sanctuary (now Neerabup Nature Reserve). 2.07 ha of the Neerabup National Park previously required for the road widening would no longer be required. The proposed Mitchell Freeway Transportation Corridor (Proposal 5) required excision of 132 ha of vegetation from the National Park.

In assessing the excisions from Neerabup National Park the EPA (2000) acknowledged the efforts in securing land for conservation purposes to achieve an overall increase in the size and improve the shape of Neerabup National Park. The loss of portions of Neerabup National Park were offset by the reservation for "Parks and Recreation" of approximately 190 ha of private land and existing reserves generally situated between the proposed Mitchell Freeway and Wanneroo Road. A further 382 ha of private land adjacent to Neerabup National Park has been reserved in previous MRS amendments. Therefore, the combined excisions and additions for MRS Amendment 992/33 and previous amendments has resulted in a net increase in the "Parks and Recreation" reservation adjacent to the Park of approximately 432 ha (WAPC 1999).

WAPC sought comments and information from the then National Parks and Nature Conservation Authority (NPNCA, now Conservation and Parks Commission) as the vestee of Neerabup National Park regarding the potential impacts of MRS Amendment 992/33 on the Park. In summary the NPNCA supported the MRS Amendment 992/33 as proposed, assuming that consolidation of the additional land occurred, future services crossing the Park were consolidated into the two east-west road carriages proposed and fauna movement mitigation measures (e.g underpasses) were considered.

Ministerial approval (Ministerial Statement 629) under Division 3 of Part IV of the EP Act was granted for MRS Amendment 992/33 on the 8 July 2003; which included the excision of land from the Neerabup National Park and Nature Reserve and addition of land to the "Parks and Recreation" reservation adjacent to the Park.

Although the combined excisions and additions following MRS Amendment 992/33 and previous MRS amendments has resulted in a net increase to the "Parks and Recreation" reservation; it is important to acknowledge several of the private property lots previously rezoned still remain in private ownership and are yet to be acquired by WAPC and subsequently amalgamated into the park. In addition, for various reasons, several of the WAPC freehold lots previously purchased for amalgamation into Neerabup National Park are yet to be formally transferred to the Conservation and Parks Commission.

1.3 Purpose and scope

Main Roads engaged GHD to develop a mitigation strategy for the proposed excisions to Neerabup National Park and Neerabup Nature Reserve. The purpose of the mitigation strategy is to document the areas to be excised from or added to Neerabup National Park and Neerabup Nature Reserve as a result of the Proposal, and the mitigation actions proposed to result in a net benefit for Neerabup National Park and Neerabup Nature Reserve.

The mitigation strategy will be presented to the Conservation and Parks Commission and other stakeholders to support the excision process.

2. Areas to be excised and added


Some areas of MRS Amendment 992/33 have previously been excised from the Neerabup National Park/Nature Reserve and/or added to the "Parks and Recreation" reservation adjacent to the Park, to facilitate the construction of the Northern Suburbs Rail System and previous stages of the Mitchell Freeway extension.

This mitigation strategy includes excision or addition of a number of small land parcels to enable the Proposal to occur, which covers:

- 8.588 ha from six areas to be excised from Neerabup National Park for the Mitchell Freeway extension and upgrade to Wanneroo Road
- 2.398 ha from one area to be excised from Neerabup Nature Reserve for the upgrade to Wanneroo Road
- 6.735 ha to be added to Neerabup National Park from three areas.

Table 1 and Table 2 provides detail on each area of land included under this strategy, including feedback from DBCA with regards to the proposed excision. The spatial context of each area presented in Figure 1, with supplementary maps for each land parcel to be excised or added presented in Appendix A for more detail. The supplementary maps correspond to the 'Map Reference' column reference in Table 1 and Table 2.

Table 1 and Table 2 and Figure 1 identify which excisions were previously considered as part of MRS Amendment 992/33, which are additional excisions to that previously considered, and which are proposed additions.

3. Mitigation actions

Historically, the excision of land from Neerabup National Park as part of MRS Amendment 992/33 has been offset by the reservation for "Parks and Recreation" under the same and earlier MRS amendments, resulting in a net increase in the "Parks and Recreation" reservation adjacent to the Park of approximately 432 ha (WAPC 1999).

As presented in Table 1 and Table 2 and Figure 1, a total of 7.287 ha of excision included in this strategy was considered as part of the EPA Assessment of MRS Amendment 992/33. The remaining 3.699 ha is newly proposed and has not been considered previously. 6.599 ha of the 6.735 ha to be added to Neerabup National Park was surplus to requirements, with this land previously proposed to be amalgamated into the Park, following the alignment of Neerabup Road moving south as part of the previous stage of the Mitchell Freeway extension.

With respect to the areas not previously considered under MRS Amendment 992/33 (Lots 10313, 700 and 705), the following site specific mitigation is proposed (detailed in Section 3.1):

- Re-instatement of fauna exclusion fencing
- Improved drainage onsite
- Protection of Black Cockatoo trees where practicable.

The following mitigation actions are proposed for the overall Proposal (detailed in Section 3.2) to provide a net benefit for Neerabup National Park and Nature Reserve:

- Installation of fauna exclusion fencing
- Installation of dual use fauna / pedestrian underpass
- Construction of carpark facilities to promote visitor access to the Park and Nature Reserve
- Access to the Yaberoo Budjara Heritage Trail
- Upgrade to access road/s within the National Park
- Landscaping with native plant species
- Weed management
- Signage.

Figure 1 presents indicative locations for the proposed mitigation actions, where these have specific locations. The exact locations of mitigation may be modified during the design process, and where this occurs it will be done in consultation with relevant stakeholders.

3.1 Site specific mitigation

3.1.1 Re-instatement of fauna exclusion fencing

Existing fauna exclusion fencing will be temporarily removed from Hester Avenue to facilitate construction of the proposed road and quarry access modifications. Temporary fencing will be established during this period. At the completion of construction, the fauna exclusion fencing will be re-instated to provide a permanent barrier to prevent uncontrolled access to protect to the Park's conservation value and reduce fauna movement across Hester Avenue. The re-instated fence will be consistent with the existing fencing (i.e. typically 1.8 m high with bottom skirting). Plate 2 provides an example of the fencing installed as part of previous stages of the Mitchell Freeway extension and proposed for this strategy.

3.1.2 Improved drainage onsite

The quarry access road south of Hester Avenue will include drainage measures to manage and reduce sheet flow from the road reserve into the Park and treat stormwater onsite as part of these modifications. It is anticipated road stormwater runoff will be treated in vegetated swales or similar measures, and infiltrated into the ground. In addition to these new measures, Main Roads will investigate options to improve the existing drainage for the western section of the quarry access, which is not proposed to be re-aligned. Options to improve drainage will consider the requirement to undertake no additional clearing of native vegetation and will be considered throughout the design process with the final selection outlined at the detailed design phase.

3.1.3 Protection of Black Cockatoo trees where practicable

Main Roads commissioned a biological survey, including a targeted Black Cockatoo habitat assessment, of the quarry access road south of Hester Avenue to inform and support the environmental assessment and approvals process. The survey was completed in spring 2019.

Eight potential Black Cockatoo breeding trees (jarrah) were identified within the survey area (with a diameter at breast height >500 mm). Of these only one tree contained hollows. This tree contained one small hollow (<6 cm) and one large hollow (greater 10 cm). No evidence of breeding was observed. The location of the potential Black Cockatoo breeding trees was confirmed using a differential GPS and shown in Plate 3. There are no potential Black Cockatoo breeding trees within Lots 10313, 700 and 705; Appendix A.

Where practicable, the design of the quarry access road and associated drainage south of Hester Avenue will avoid and protect the potential Black Cockatoo breeding trees identified. This will occur though refinement of the project and construction footprint.




Plate 3 Potential Black Cockatoo breeding trees near quarry access road south of Hester Avenue

Main Roads will apply the following mitigation actions during design and construction of the quarry access road:

- Clearing of native vegetation will be limited to area required for safe construction and operation, in accordance with Main Roads standards
- Mature trees will be retained as far as practicable and will not be removed for temporary construction works.

3.2 Park focused mitigation

3.2.1 Installation of fauna exclusion fencing

Fauna exclusion fencing will be constructed to provide a barrier to prevent uncontrolled vehicular access and illegal rubbish dumping, to protect to the Park's conservation value. The fence will also reduce uncontrolled access by pedestrians, cyclists and off road vehicles. The enhanced access controls will help to minimise the spread of dieback and weeds into the Park and the risk of uncontrolled fire outbreaks.

The fencing will typically be 1.8 m high with bottom skirting, to minimise fauna interaction with adjacent roads and urban areas. The design will be consistent with the existing fencing proposed to be re-instated under Section 3.1.1 and shown in Plate 2.

The fence installation will allow the incorporation of fire breaks to be established at the boundary of the road reserve and Neerabup National Park. This will reduce indirect impacts and allow improved access, to facilitate management of weed infestation and reduce fire risks. DBCA

requested that the contractor installing the fence be engaged to clear on the National Park side of the fence. This activity can proceed under a DBCA Regulation 4 permit.

Main Road will install fencing on the eastern side of the Mitchell Freeway extension, Romeo Road and small portions of Wanneroo Road. The fencing will be integrated with existing fencing to impede unauthorised human access to Neerabup National Park; and proposed dual use fauna / pedestrian underpass to guide fauna through these access structures to aid safe movement between vegetated areas.

If funding is available, Main Roads will extend the fauna exclusion fencing from Hester Avenue to Romeo Road on the western side of Wanneroo.

3.2.2 Fauna/pedestrian underpass

To maintain and improve fauna linkages between the Neerabup National Park and remnant bushland to the north and west, two dual use pedestrian / fauna underpasses (approximately 2.7 m high x 4.6 m wide) are proposed to be installed. One underpass will be incorporated in the Proposal, under Romeo Road where the Yaberoo Budjara Heritage Trail intersects the road. If funding is available a second underpass will be installed under Wanneroo Road to create a linkage between the National Park and Nature Reserve.

In addition to benefitting the movement of ground dwelling fauna, the installation of the underpasses will support and facilitate public access, enjoyment and use of the park and reserve. Plate 4 provides an example of a dual use pedestrian / fauna underpass, which was installed under Hester Avenue to provide a linkage within Neerabup National Park following road construction.

3.2.3 Construction of carpark facilities

Installation of a carpark on the north-west corner of Neerabup Nature Reserve is proposed, along with associated road modifications to support the walk trail under construction by DBCA. The proposed car park is east of Wanneroo Road at approximate Straight Line Kilometre (SLK) 38.

The location of the proposed carpark (and associated Neerabup Nature Reserve improvements) are shown in Plate 5. Whereas Plate 6 provides an indicative carpark layout and associated road modifications. It is proposed the carpark will include:

- Six car bays and two long vehicle bays
- Limestone base and/or sealed
- Long vehicle turn around at the end of the road
- Retained access to the management tracks
- Collector path to trailhead.

Construction of carpark facilities will improve the visitor access and nature experience to Neerabup Nature Reserve. It may also provide another potential access connection to the Yaberoo Budjara Heritage Trail within the Neerabup National Park. This future trail connection would be the responsibility of DBCA to construct and could be planned to utilise the proposed underpass on Wanneroo Road between the Neerabup National Park and Nature Reserve.

3.2.4 Access to the Yaberoo Budjara Heritage Trail

DBCA has communicated the importance of encouraging use of Neerabup National Park by the public. To facilitate use of the existing Yaberoo Budjara Heritage Trail within the National Park (see Plate 7) managed access is required. Main Roads will incorporate an access control point into the Proposal design to create an additional link to the heritage trail.

Preliminary conversations with DBCA identified the Mitchell Freeway extension / Lukin Drive interchange as the preferred location for the heritage trail access control point. This location was selected to encourage the local Butler community and public that utilise the Principal Shared Path (PSP) to access the National Park.

The Proposal will incorporate a PSP alongside Mitchell Freeway between Hester Avenue and Romeo Road. This PSP is identified in the Department of Transport's Principal Shared Path Expansion Program, which is a key action of the Western Australian Bicycle Network Plan. This separate, but integrated initiative, will provide access to a larger proportion of the community.

The existing Yaberoo Budjara Heritage Trail will be realigned where it intersects the Mitchell Freeway proposed road corridor. DBCA will be engaged to facilitate potential clearing required within the National Park, to ensure amenity and interpretation of the trail within the native vegetation rather than along the freeway fencing.

3.2.5 Access road upgrade to park

DBCA currently have a number of formal and informal locations along Wanneroo Road to gain vehicle access to Neerabup National Park. Main Roads, in consultation with DBCA, has identified one location where upgrades will occur to improve and manage vehicle access. This consolidation of access roads into the Park will reduce the risk of vehicle access by unauthorised individuals. The DBCA consolidated access point will involve:

- Sufficient line of sight to allow vehicles to safely depart and enter traffic
- Sufficient space to allow temporary vehicle stopping
- Vehicle access for vehicles traveling north or south.

3.2.6 Landscaping with native species

The Development Envelope will include landscaping/revegetation comprising a mix of local, native species. This landscaping will provide a buffer between the road corridor and the Neerabup National Park and Neerabup Nature Reserve. The presence of a managed, native vegetation buffer will further minimise potential edge impacts into the National Park and Nature Reserve.

The landscaping will:

• Be designed to be self-sustaining, structurally and species diverse vegetation, with minimal watering requirements for establishment

- Utilise local provenance, native species to revegetate areas adjacent to Neerabup National Park and Neerabup Nature Reserve
- Not include Black Cockatoo foraging or breeding plant species within 10 m of the road
- Integrate with fauna/pedestrian underpasses, where appropriate
- Be maintained for the first three years (at least two summers) following establishment, including monitoring and weed control within and adjacent to revegetation / landscaping areas.

3.2.7 Weed management

The flora and vegetation survey (GHD 2019) of the Proposal Development Envelope and buffer recorded eight Declared Pests under the Western Australian *Biosecurity and Management Act 2007* and four Weeds of National Significance (WoNS):

- *Moraea flaccida (One-leaf Cape Tulip) Declared Pest
- *Gomphocarpus fruticosus (Narrowleaf Cottonbush) Declared Pest
- *Echium plantagineum (Paterson's Curse) Declared Pest
- *Solanum linnaeanum (Apple of Sodom) Declared Pest
- * Opuntia stricta (Common Prickly Pear) Declared Pest and WoNS
- *Lantana camara (Common Lantana) Declared Pest and WoNS
- *Asparagus asparagoides (Bridal Creeper) Declared Pest and WoNS
- *Zantedeschia aethiopica (Arum lily) Declared Pest and WoNS.

The predominant Declared Pests recorded were *A. asparagoides* and *M. flaccida*, with isolated records of other Declared Pests.

Active weed management within the Proposal Development Envelope will reduce the risk of indirect impacts to the Neerabup National Park from construction and operation of the Proposal. Weed management will be supported by the introduction of the fauna exclusion fencing (see Section 3.2.1) and landscaping with native species (see Section 3.2.6).

The following management measures will be implemented:

- Declared Plants within the Development Envelope will be treated according to their Control Codes and advice from Department of Primary Industries and Regional Development (DPIRD), with the aim of eradication where possible but as a minimum prevent off site movement
- WoNS and environmental weeds within the Development Envelope will be treated according to the weed control management outlined by Weeds Australia (http://weeds.ala.org.au/) with the aim of controlling off-site movement
- Topsoil containing Declared Pests or WoNS shall not be reused in landscaping or revegetation.
- All heavy plant and machinery will be inspected by the contractor prior to entry at the work site and be confirmed to be clean and free of vegetation and soil material
- Topsoil from infected or potentially infected Phytophthora dieback areas (including within 20 m of mapped *P. multivora* and *P. nicotianae* infected sites) shall be segregated and not used in non-infected areas
- Clean on Entry and/or Exit (CoE) procedures will be implemented on site, and entry and exit records kept for CoE points.

Main Roads will also investigate the need for weed surveys within the Neerabup National Park adjacent to the Development Envelope. This assessment would provide a baseline to allow potential indirect impacts associated with the Proposal to be monitored and managed through construction.

3.2.8 Interpretative signage

Main Roads will consult with BDCA to construct two new signs to encourage the use of Neerabup National Park. One of these signs will be located in association with the new access control point (see Section 3.2.4), with the other potentially sited in association with one of the fauna/pedestrian underpass (see Section 3.2.2).






Appendix A - Maps for each land parcel to be excised or added




