The City of Karratha is the primary interest holder of LOT 302.</p> <p>Clearing of vegetation within the application area is required for reconstruction and realignment of an existing transportation corridor, Bayly Avenue, which provides primary access to the Karratha Airport, located in the Town of Karratha Western Australia.</p>
