## Application for a clearing permit (area permit)

Environmental Protection Act 1986, section 51E

### FORM C1

Clearing of native vegetation is prohibited in Western Australia except where a clearing permit has been granted or an exemption applies. A person who causes or allows unauthorised clearing commits an offence.

In the short term, the avoidance of responsibility for forest health and community protection would avoid the need for tree removal. But in the long term, uncontrolled stock access, exclusion of fire and absence of regeneration will ensure that declining ecological function will be perpetuated, and the forest will eventually collapse.</p>
