The proposed shared path underwent several re-designs to ensure tree retention was maximised. Two sections of the path are proposed to be elevated to ensure the retention of large, iconic trees. A section of the path near Beckenham Station is proposed to be constructed of concrete to minimise disturbance to the significant trees.
