A proposal was put forward for the construction of 20 parking bays along Capricorn Esplanade.</p> <p>Additionally, the provision of additional car parking bays will assist in alleviating the concerns of future tenants of the Yanchep Surf Club facility regarding adequate parking to support sustainable operations.</p> <p>No other sites within the area were found to be suitable for the construction of car parking bays.</p>
