	<p>If yes, provide details:</p> <p>The vegetation on Mingenew-Mullewa road is located on an embankment that needs to be removed in order to allow for the widening of the road consistent with the current and forecasted future traffic volumes to a 7.2m wide sealed carriageway.</p> <p>The trees on Milo Road are very close to the existing road, and this carriageway is also being widened. Due to plans to upgrade the road there are no alternatives but to remove the two encroaching trees, however care has been taken to minimise the number of trees which will be removed to the lowest possible number.</p>
