The accommodation of the bus terminus in the existing car park was not supported by the PTA and the PTA required a separated facility for effective operation due to the over utilisation of the existing car park by patrons accessing Penguin Island.</p> <p>The scale of clearing at the site has also been scaled back to reduce the impact on existing native vegetation.</p>
