	<p>Purpose of clearing</p> <p>As part of the 2020/21 Budget funds have been allocated to some clearing works along Fawcett Road, Hamel. Fawcett Road is a main access road for local farmers, residents and produce farms. The section of Fawcett road from SLK 2000 to 4100 has a substantial amount of vegetation build-up which has resulted in the vegetation becoming overgrown and unmanageable. In some locations the vegetation has grown within the table drains which has resulted in the vegetation growing on a lean towards the road which has made it difficult to prune without compromising the tree structure.</p>

In addition some additional maintenance pruning has previously been completed however the native vegetation has grown substantially and is now causing impact to road users.</p>
