The clearing of native vegetation is prohibited in Western Australia unless a clearing permit has been granted for the clearing or where a permit is not required (either due to a referral determination that one is not needed or because an exemption applies). A person who causes or allows unauthorised clearing commits an offence.

The construction of the path will largely avoid impacts to native vegetation and will not intrude into <i>Macarthuria keigheryi</i> habitat areas relevant to CPS 9049/2 and associated BC Act authorisation TFL 74-2021.</p> <p>The altering of the fence to accommodate the path is in accordance with advice from DBCA, who have requested that there are no paths into the areas of <i>Macarthuria keigheryi</i> habitat.</p> <p>Condition 12(c) of CPS 9049/2 requires the installation of a fence around retained vegetation adjacent to the application area. The location of the fence is proposed to be modified to facilitate the unimpeded use of the pedestrian path as per the attached shapefile and map,</p> <p>An increase of 0.02 ha is proposed for the amended application area. However, the construction of the proposed path section will require the clearing of approximately 5 m² or less of additional native vegetation along with revegetated native plants that do not represent native vegetation in accordance with the definition provided under the <i>Environmental Protection Act 1986</i>. The additional native vegetation that would be cleared comprises scattered individuals of <i>Eragrostis elongata</i> (a grass). In addition, it is noted that at least 0.37 ha of native vegetation that was approved for removal in the initial application has been retained as part of the development of the State Football Centre.</p>
