# Application for an amendment to a clearing permit

Environmental Protection Act 1986, section 51M

## FORM C4

Clearing of native vegetation is prohibited in Western Australia except where a clearing permit has been granted or an exemption applies. A person who causes or allows unauthorised clearing commits an offence.

Vegetation will be cleared with mechanised machinery; vegetation will then be removed with a loader and stockpiled as growth medium for nearby rehabilitation. The top 150mm of topsoil will also be removed and stockpiled for rehabilitation.</p>
<p>For an application to amend the size of the area permitted to be cleared, or add a land parcel to the clearing permit, you must have the authority of the landowner to access the land and undertake the clearing.</p>	<p>State the nature of the applicant's authority to access the land to be cleared. Evidence of authority can include e.g. a copy of the certificate of title or a letter of authority signed by the landowner or other person with authority to give legal land access permission.</p> <p><i>[Attach evidence of authority.
