	<p>If yes, provide details:</p> <p>The only alternative in the context of this site is to place the footpath directly on the beach, which is not feasible as will get washed away. Other options away from the beach are not possible due to encroachment of the upcoming Flinders Stage 3 development and restrictions with other private property. Additionally, clearing has been avoided by aligning some of the pathway in existing cleared footprints, such as underneath powerlines. Where possible the alignment has also reduced clearing by putting it mostly on the road shoulders, where possible.</p>
