Environmental Protection Act 1986, section 51KA

The clearing of native vegetation is prohibited in Western Australia unless a clearing permit has been granted for the clearing or where a permit is not required (either due to a referral determination that one is not needed or because an exemption applies). A person who causes or allows unauthorised clearing commits an offence.

This extension will allow for artificial hollows to be installed in known breeding areas such as the Stirling Ranges which will deliver a better environmental outcome for Black Cockatoos.</p> <p>Condition 11(a) - <i>Within 24 months of commencing clearing authorised under this Permit, in consultation with the Department of Biodiversity, Conservation and Attractions, the Permit Holder must install a western ringtail possum (Pseudocheirus occidentalis) rope bridge within the area cross-hatched red in Figure 1(e) of Schedule 2 to allow the safe movement of western ringtail possum(s) (Pseudocheirus occidentalis) between remnants of native vegetation.</i></p> <p>As road construction is still underway, construction of the rope bridge has not been possible to date. Main Roads seeks an amendment to Condition 11(a) to state "Within 36 months of commencing clearing" to enable installation of the rope bridge once the road formation has been completed.</p> <p>Condition 16 (c) - <i>Within 24 months of the commencement of clearing authorised under this Permit and no later than 1 December 2026, the Permit Holder must:</i></p> <p><i>(i) give a conservation covenant issued under section 30B of the Soil and Land Conservation Act 1945, setting aside the revegetated and rehabilitated areas cross-hatched green in Figure 1(g) and Figure 1(h) of Schedule 2 for the protection and management of native vegetation in perpetuity; and (ii) provide to the CEO a copy of the executed conservation covenant.</i></p> <p>Given construction is still underway and the areas requiring revegetation and conservation covenant are still being used by the Project, Main Roads seeks to amend Condition 16(c) such that the conservation covenant process does not have to be completed until 24 months after the finalisation of clearing authorised under this permit.</p> <p>Condition 17(a) - <i>Within 12 months of the commencement of clearing authorised under this Permit, the Permit Holder must submit a Project Rehabilitation Plan to the CEO for approval for the areas cross-hatched red in Figure 1(g) and Figure 1(h) of Schedule 2,</i></p>
