AUTHORISED ACTIVITY




Figure 1: Map of the boundary of the area within which clearing may occur

The permit holder must not clear more than 5.11 hectares of *native vegetation* within the area cross-hatched yellow in Figures 1-5 of Schedule 1.

CONDITIONS

1. Avoid, minimise, and reduce impacts and extent of clearing

In determining the *native vegetation* authorised to be cleared under this permit, the permit holder must apply the following principles, set out in descending order of preference:

- (a) avoid the clearing of *native vegetation*;
- (b) minimise the amount of *native vegetation* to be cleared; and
- (c) reduce the impact of clearing on any environmental value.

2. Weed management

When undertaking any clearing authorised under this permit, the permit holder must take the following measures to minimise the risk of introduction and spread of *weeds*:

- (a) clean earth-moving machinery of soil and vegetation prior to entering and leaving the area to be cleared;
- (b) ensure that no known *weed*-affected soil, mulch, fill, or other material is brought into the area to be cleared; and
- (c) restrict the movement of machines and other vehicles to the limits of the areas to be cleared.

3. Directional clearing

The permit holder must conduct clearing activities in a slow, progressive manner toward adjacent native vegetation to allow fauna to move into adjacent native vegetation ahead of the clearing activity.

4. Records that must be kept

The permit holder must maintain records relating to the listed relevant matters in accordance with the specifications detailed in Table 1.

1.	In relation to the authorised clearing activities generally	(a)	the species composition, structure, and density of the cleared area;
		(b)	the location where the clearing occurred, recorded using a Global Positioning System (GPS) unit set to Geocentric Datum Australia 1994 (GDA94), expressing the geographical coordinates in Eastings and Northings;
		(c)	the date that the area was cleared;
		(d)	the size of the area cleared (in hectares);
		(e)	actions taken to avoid, minimise, and reduce the impacts and extent of clearing in accordance with condition 1;
		(f)	actions taken to minimise the risk of the introduction and spread of weeds and dieback in accordance with condition 2; and
		(g)	direction of clearing in accordance with condition 3.

5. Reporting

The permit holder must provide to the *CEO* the records required under condition 4 of this permit when requested by the *CEO*.




Figure 2: Map of the boundary of the area within which clearing may occur




Figure 3: Map of the boundary of the area within which clearing may occur




Figure 4: Map of the boundary of the area within which clearing may occur




Figure 5: Map of the boundary of the area within which clearing may occur
