	 The project footprint has been selected to minimize impacts on soils/land that are not critical to the project. Most of the wetland area in Lot 6 has been avoided, including a circa 0.5 ha patch with Peppermints and hollow trees. Trees along the northern boundary of Lot 6, including several with hollows, will be retained to provide a partially vegetated corridor (circa 1.4 ha). Additional planting will be carried out along the eastern boundary of Lot 6 however the exact nature and extent of this is still to be confirmed. Vegetation in the east of Lot 8 will be retained to provide a substantial vegetated corridor. Vegetation along the western boundary of Lot 8 (where the WRP) was observed will be retained. Proposed buffer planting will be carried out along the northern and north eastern boundaries of Lot 8 with local native provenance species. The artificial dams (3) will be retained, providing watering points for fauna. Many of the large trees along the edge of the development footprint will need to be cleared due to the unacceptable risk to human life (farm workers) if they were to be retained as individual isolated trees.
