The purpose of this permit was for a geotechnical investigation. DWER staff (J Galba) recommended that a new clearing permit application be prepared, rather than amending the existing permit. As the purpose of the new clearing activity, excavation of in-situ soil material, was different to the existing permit, DWER will need to conduct a new environmental impact assessment.
