*Environmental Protection Act 1986, section 51E*

Purpose of clearing	
City of Bunbury (the City) is developing a youth precinct along the edge of the section of Leschenault Inlet foreshore of Luciana Park within the town centre. The project design has been facilitated by the City of Bunbury and incorporated the ideas generated by the City of Bunbury community and the City's Youth Advisory council. Part of the design has incorporated expanding the beach front area at the northern end of the Leschenault

Of the 22 flora species identified, only four native flora species are present within the proposed clearing area including <i>Ficinia nodosa</i>, <i>Lepidosperma gladiatum</i>, <i>Frankenia pauciflora</i> and <i>Acacia saligna</i> (Natural Area 2021) (Appendix A). Due to the condition of the vegetation present in the proposed clearing area and the majority of species being non-native the City did not consider that there would be value in avoiding or minimising impacts to this vegetation.</p> <p>Further to the proposed removal of the vegetation the City will be planting a majority Australian native species throughout the Youth Precinct site (Appendix B).</p>
