Lot 681 on Deposited Plan 188395, Bunbury

Unidentified Water Reserve (PIN 1248453), Bunbury

AUTHORISED ACTIVITY

The permit holder must not clear more than 0.099 hectares of *native vegetation* within the area cross-hatched yellow in Figure 1 of Schedule 1.

CONDITIONS

1. Avoid, minimise, and reduce impacts and extent of clearing

In determining the *native vegetation* authorised to be cleared under this permit, the permit holder must apply the following principles, set out in descending order of preference:

- (a) avoid the clearing of *native vegetation*;
- (b) minimise the amount of *native vegetation* to be cleared; and
- (c) reduce the impact of clearing on any environmental value.

2. Weed and dieback management

When undertaking any clearing authorised under this permit, the permit holder must take the following measures to minimise the risk of introduction and spread of *weeds* and *dieback*:

- (a) clean earth-moving machinery of soil and vegetation prior to entering and leaving the area to be cleared;
- (b) ensure that no known *dieback* or *weed*-affected soil, mulch, fill, or other material is brought into the area to be cleared; and
- (c) restrict the movement of machines and other vehicles to the limits of the areas to be cleared.

3. Wind erosion management

The permit holder must commence construction of the Bunbury Youth Precinct no later than two months after undertaking the authorised clearing activities to reduce the potential for wind erosion.

4. Records that must be kept

The permit holder must maintain records relating to the listed relevant matters in accordance with the specifications detailed in Table 1.

Table 1: Records that must be kept

No.	Relevant matter	Specifications	
1.	In relation to the authorised clearing activities generally	(a)	the species composition, structure, and density of the cleared area;
		(b)	the location where the clearing occurred, recorded using a Global Positioning System (GPS) unit set to Geocentric Datum Australia 1994 (GDA94), expressing the geographical coordinates in Eastings and Northings;
		(c)	the date that the area was cleared;
		(d)	the date that construction activities commenced;
		(e)	the size of the area cleared (in hectares); and
		(f)	actions taken to avoid, minimise, and reduce the impacts and extent of clearing in accordance with condition 1; and
		(g)	actions taken to minimise the risk of the introduction and spread of <i>weeds</i> and <i>dieback</i> in accordance with condition 2.

5. Reporting

The permit holder must provide to the *CEO* the records required under condition 4 of this permit when requested by the *CEO*.

DEFINITIONS

In this permit, the terms in Table have the meanings defined.

clearing	has the meaning given under section 3(1) of the EP Act.

dieback	means the effect of <i>Phytophthora</i> species on native vegetation.		
department	means the department established under section 35 of the <i>Public Sector Management Act 1994</i> (WA) and designated as responsible for the administration of the EP Act, which includes Part V Division 3.		
EP Act	Environmental Protection Act 1986 (WA)		
native vegetation	has the meaning given under section 3(1) and section 51A of the EP Act.		
	means any plant –		
	(a) that is a declared pest under section 22 of the <i>Biosecurity and Agriculture Management Act 2007</i> ; or		
weeds	(b) published in a Department of Biodiversity, Conservation and Attractions species-led ecological impact and invasiveness ranking summary, regardless of ranking; or		
	(c) not indigenous to the area concerned.
