## Application for a clearing permit (area permit)

*Environmental Protection Act 1986, section 51E*

### FORM C1

Clearing of native vegetation is prohibited in Western Australia except where a clearing permit has been granted or an exemption applies. A person who causes or allows unauthorised clearing commits an offence.

However this option was discounted as it will have substantial impact on native vegetation at the northern verge.</p> <p>With the pre-deflection encroaching into the southern verge, the scale of clearing of native vegetation is significantly less than clearing native vegetation at the northern verge. This selected option is to reduce the impact on existing native vegetation in this area.</p>
