

CLEARING PERMIT

Granted under section 51E of the Environmental Protection Act 1986

Purpose Permit number:	9411/2
Duration of Permit:	From 16 November 2021 to 15 November 2026
Permit Holder:	Raymond Francis

The Permit Holder is authorised to clear native vegetation subject to the following conditions of this Permit.

PART I - CLEARING AUTHORISED

1. Land on which clearing is to be done

Mining Lease 51/12 Mining Lease 51/31 Mining Lease 51/96 Mining Lease 51/572 Mining Lease 51/794

2. Clearing authorised (purpose)

The Permit Holder is authorised to clear native vegetation for the purpose of prospecting activities.

3. Area of Clearing




Figure 1: Map of the boundary of the area within which clearing may occur

The Permit Holder must not clear more than 10 hectares of native vegetation within the area cross-hatched yellow and shaded red in Figure 1 of Schedule 1.

4. Clearing Restricted

The Permit Holder must not clear more than 4 hectares of native vegetation within the area shaded red in Figure 1 of Schedule 1.

5. Type of Clearing Authorised

The Permit Holder shall not clear native vegetation unless the purpose for which the clearing is authorised is enacted within six months of the authorised clearing being undertaken.

6. Application

This Permit allows the Permit Holder to authorise persons, including employees, contractors and agents of the Permit Holder, to clear native vegetation for the purposes of this Permit subject to compliance with the conditions of this Permit and approval from the Permit Holder.

PART II - MANAGEMENT CONDITIONS

7. Avoid, minimise and reduce the impacts and extent of clearing

In determining the amount of native vegetation to be cleared authorised under this Permit, the Permit Holder must have regard to the following principles, set out in order of preference:

- (a) avoid the clearing of native vegetation;
- (b) minimise the amount of native vegetation to be cleared; and
- (c) reduce the impact of clearing on any environmental value.

8. Weed control

When undertaking any clearing or other activity authorised under this Permit, the Permit Holder must take the following steps to minimise the risk of the introduction and spread of *weeds*:

- (a) clean earth-moving machinery of soil and vegetation prior to entering and leaving the area to be cleared;
- (b) ensure that no known *weed*-affected soil, *mulch, fill* or other material is brought into the area to be cleared; and
- (c) restrict the movement of machines and other vehicles to the limits of the areas to be cleared.

9. Vegetation Management

- (a) where practicable the Permit Holder shall avoid clearing riparian vegetation; and
- (b) where a *watercourse* or *wetland* is to be impacted by clearing, the Permit Holder shall ensure that the existing surface flow is maintained.

PART III - RECORD KEEPING AND REPORTING

10. Records to be kept

The Permit Holder must maintain records relating to the listed relevant matters in accordance with the specifications detailed in Table 1.

11. Reporting

- (a) The Permit Holder shall provide a report to the CEO by 1 October each year for the life of this Permit, demonstrating adherence to all conditions of this Permit, and setting out the records required under condition 10 of this Permit in relation to clearing carried out between 1 July and 30 June of the previous financial year.
- (b) If no clearing authorised under this Permit was undertaken between 1 July and 30 June of the previous financial year, a written report confirming that no clearing under this permit has been carried out, must be provided to the *CEO* by 1 October of each year.
- (c) Prior to 15 November 2026, the Permit Holder must provide to the CEO a written report of records required under condition 10 of this Permit where these records have not already been provided under condition 11(a) or 11(b) of this Permit.

DEFINITIONS

In this Permit, the terms in Table 2 have the meanings defined.

condition/s	a condition to which this clearing permit is subject under section 51H of the EP Act.		
fill	means material used to increase the ground level, or to fill a depression.		
department	means the department established under section 35 of the <i>Public Sector</i> <i>Management Act 1994</i> (WA) and designated as responsible for the administration of the EP Act, which includes Part V Division 3.		
EP Act	Environmental Protection Act 1986 (WA)		
mulch	means the use of organic matter, wood chips or rocks to slow the movement of water across the soil surface and to reduce evaporation.		
native vegetation	has the meaning given under section 3(1) and section 51A of the EP Act.		
riparian vegetation	has the meaning given to it in Regulation 3 of the Environmental Protection (Clearing of Native Vegetation) Regulation 2004.		
watercourse	has the meaning given to it in section 3 of the <i>Rights in Water and Irrigation Act 1914.</i>		
weed/s	 means any plant – (a) that is a declared pest under section 22 of the <i>Biosecurity and Agriculture Management Act 2007</i>; or (b) published in a Department of Biodiversity, Conservation and Attractions species-led ecological impact and invasiveness ranking summary, regardless of ranking; or (c) not indigenous to the area concerned. 		
wetland/s	means an area of seasonally, intermittently or permanently waterlogged or inundated land, whether natural or otherwise, and includes a lake, swamp, marsh, spring, dampland, tidal flat or estuary.

The boundary of the area authorised to be cleared is shown in the map below (Figure 1).
