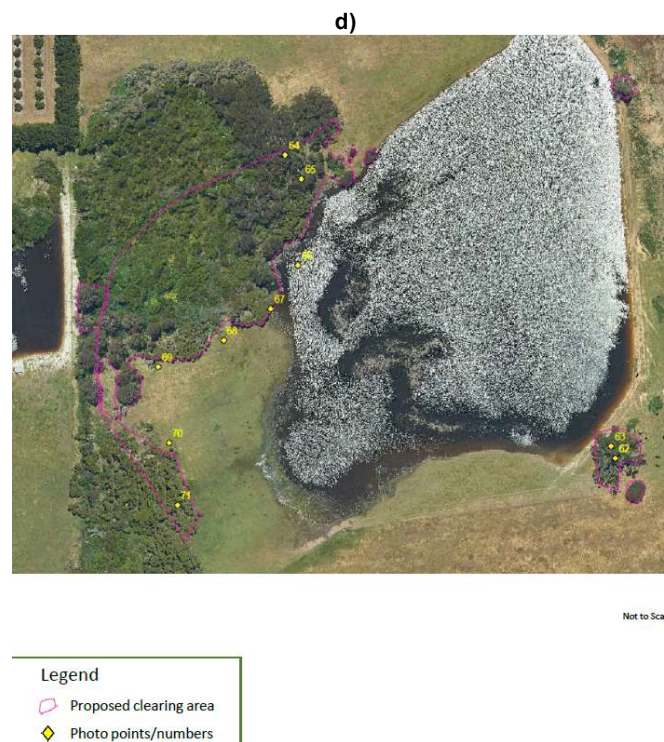
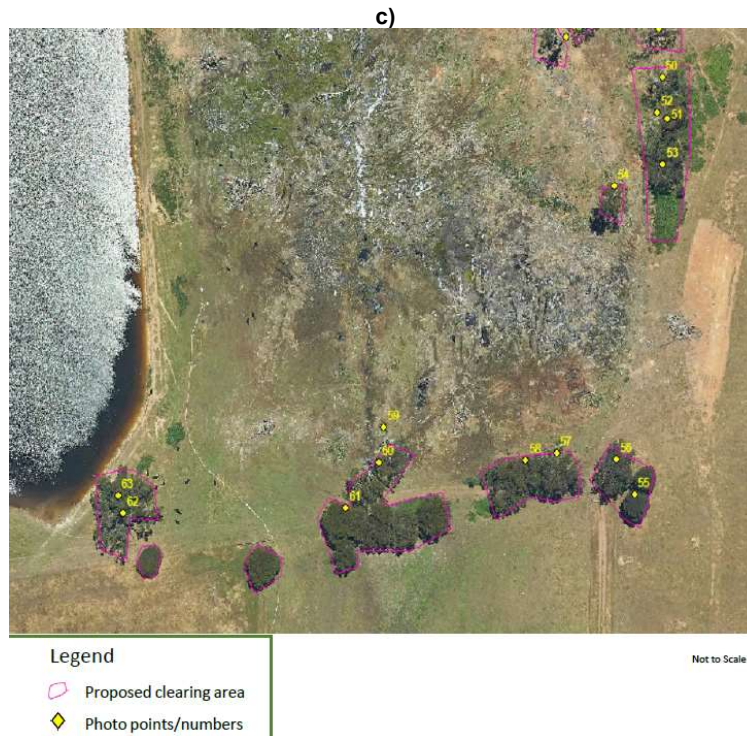


Figure 1(a-d). Location of photo points within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

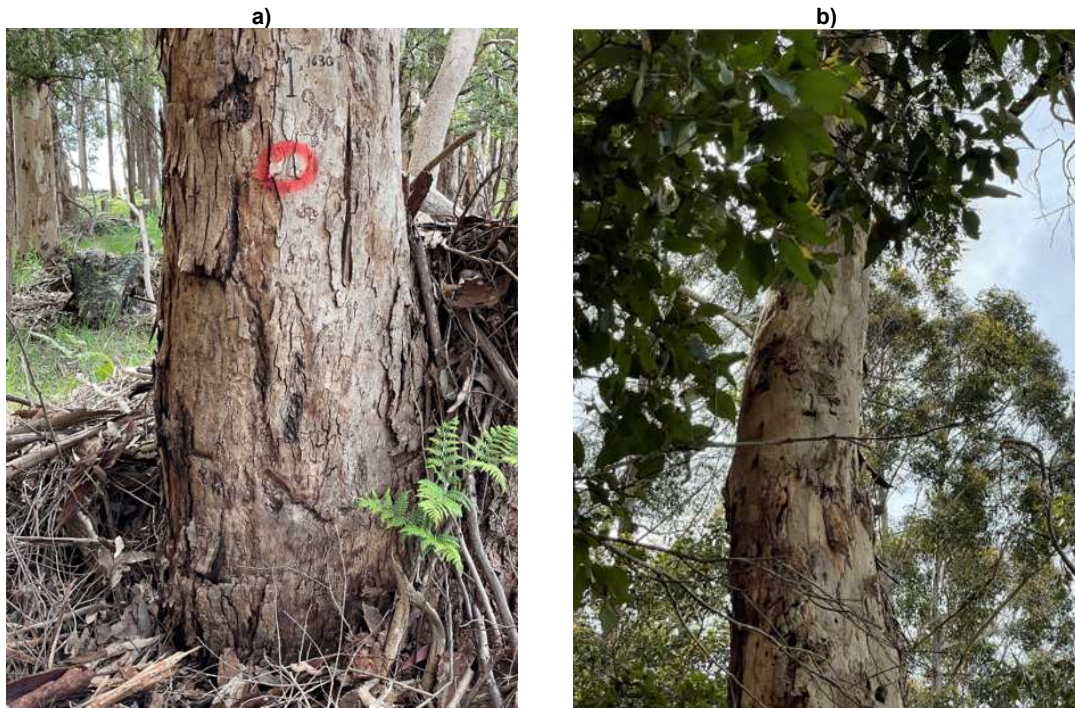


Figure 2(a-b). Photographs of Tree 1 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

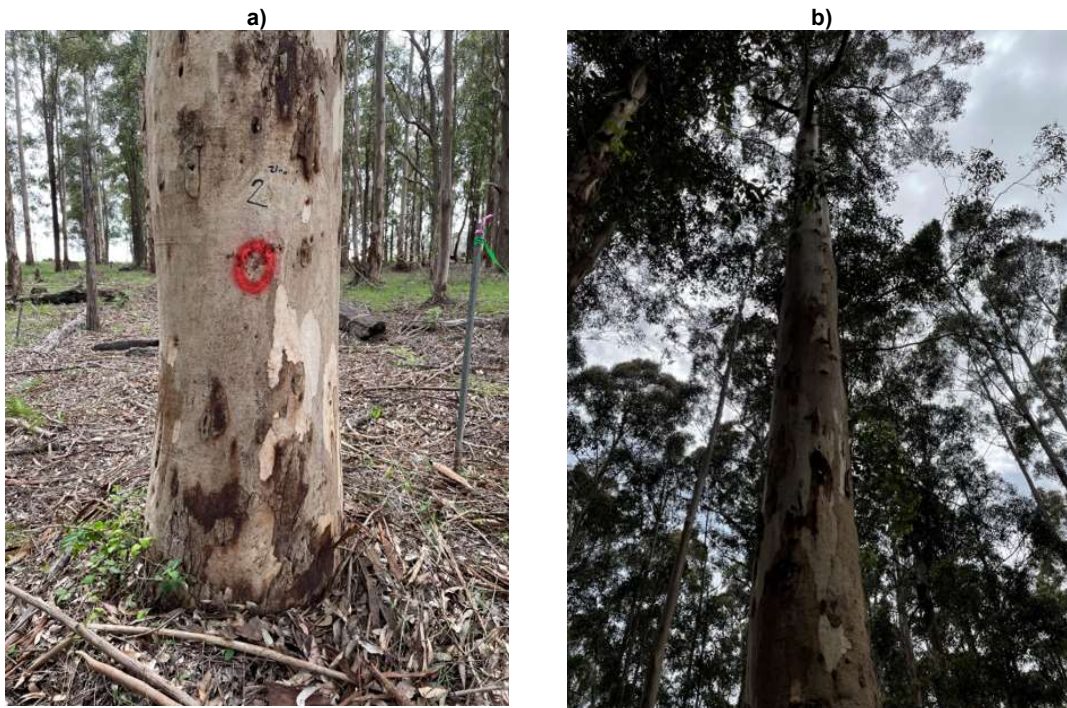


Figure 3(a-b). Photographs of Tree 2 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

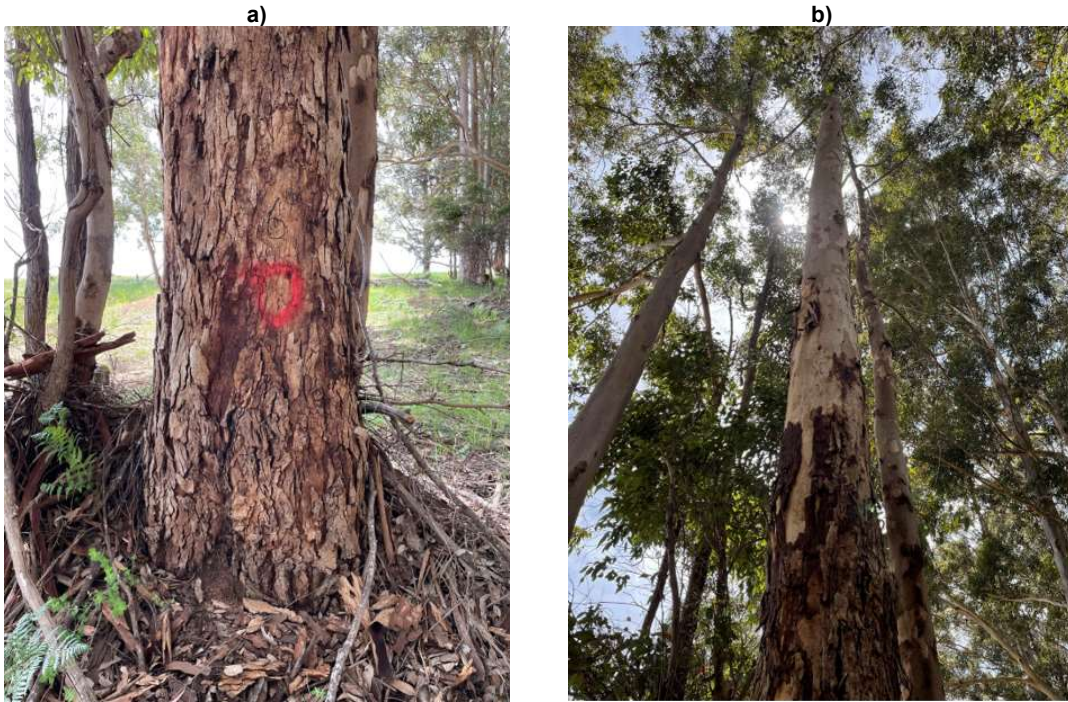


Figure 4(a-b). Photographs of Tree 6 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

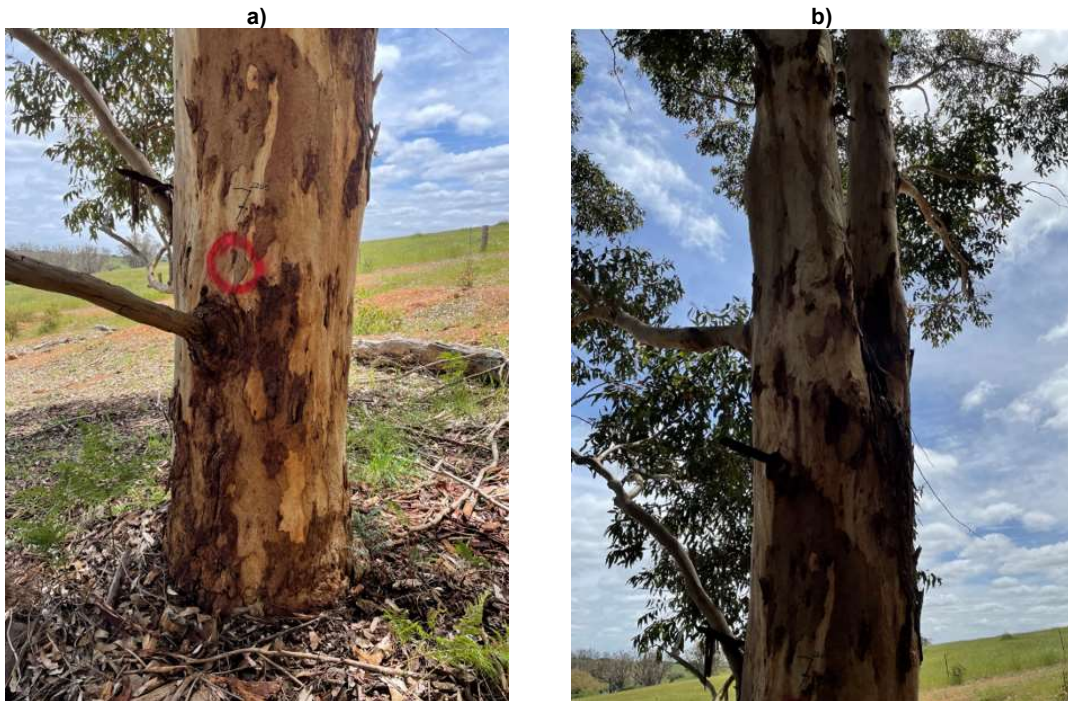


Figure 5(a-b). Photographs of Tree 7 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

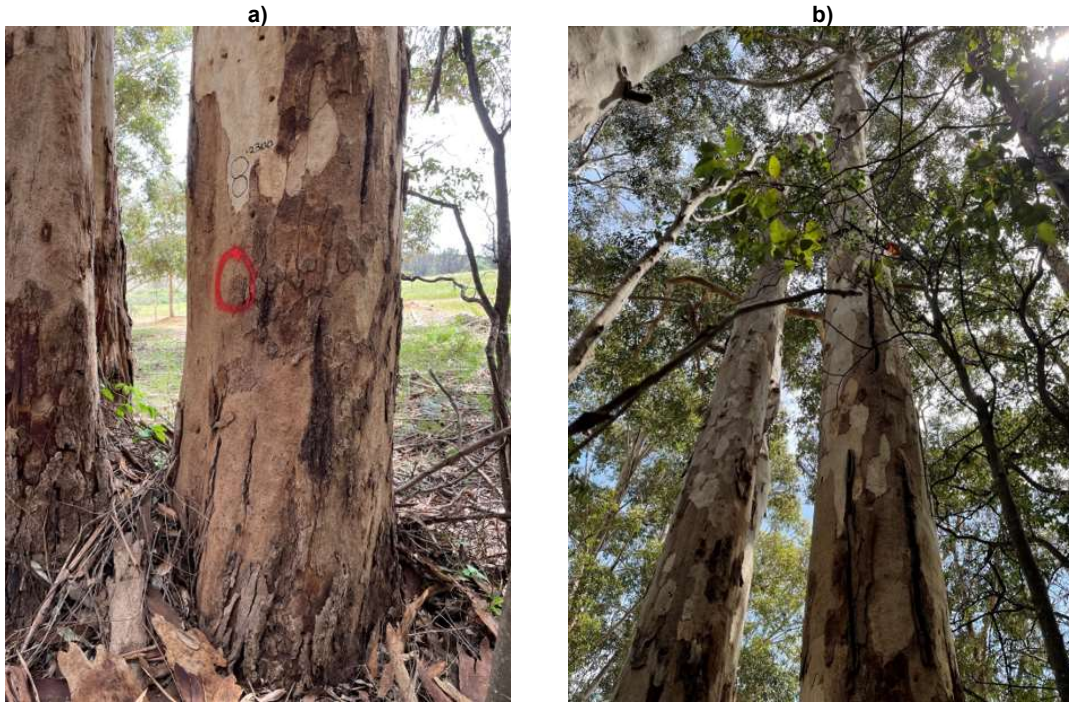


Figure 6(a-b). Photographs of Tree 8 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

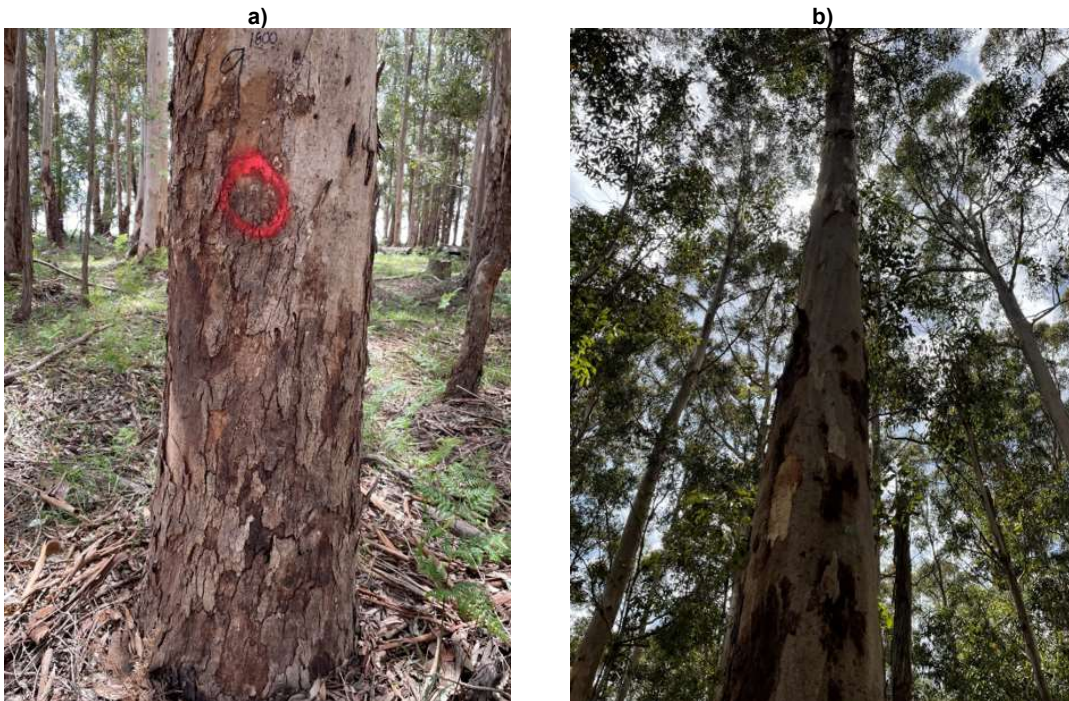


Figure 7(a-b). Photographs of Tree 9 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

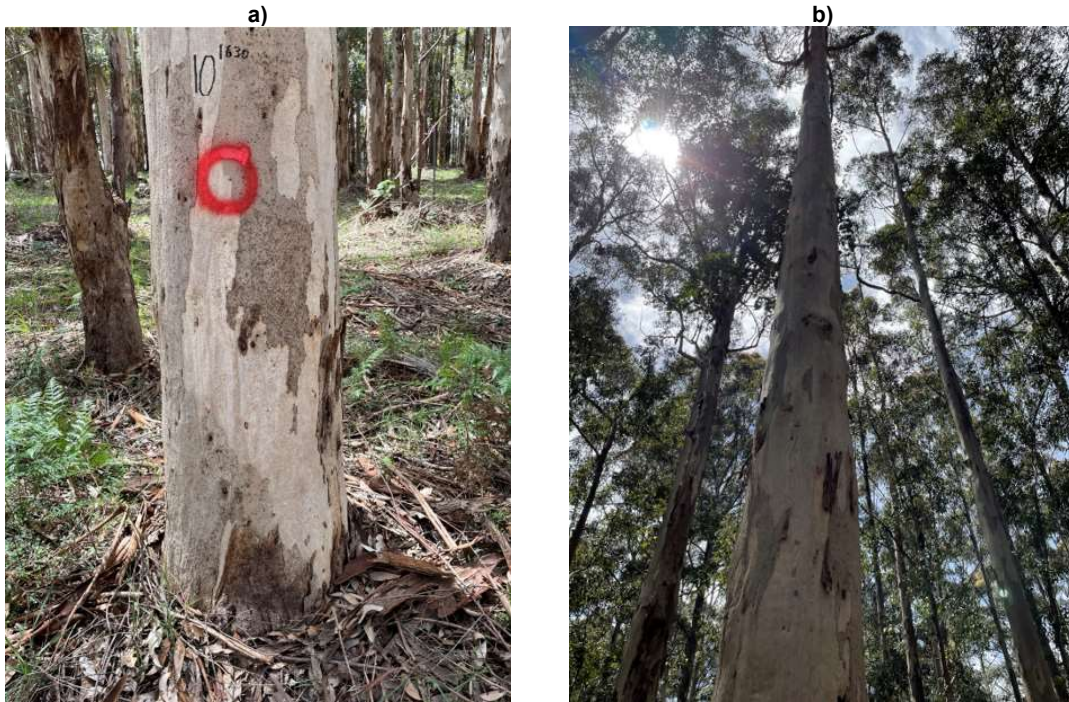


Figure 8(a-b). Photographs of Tree 10 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

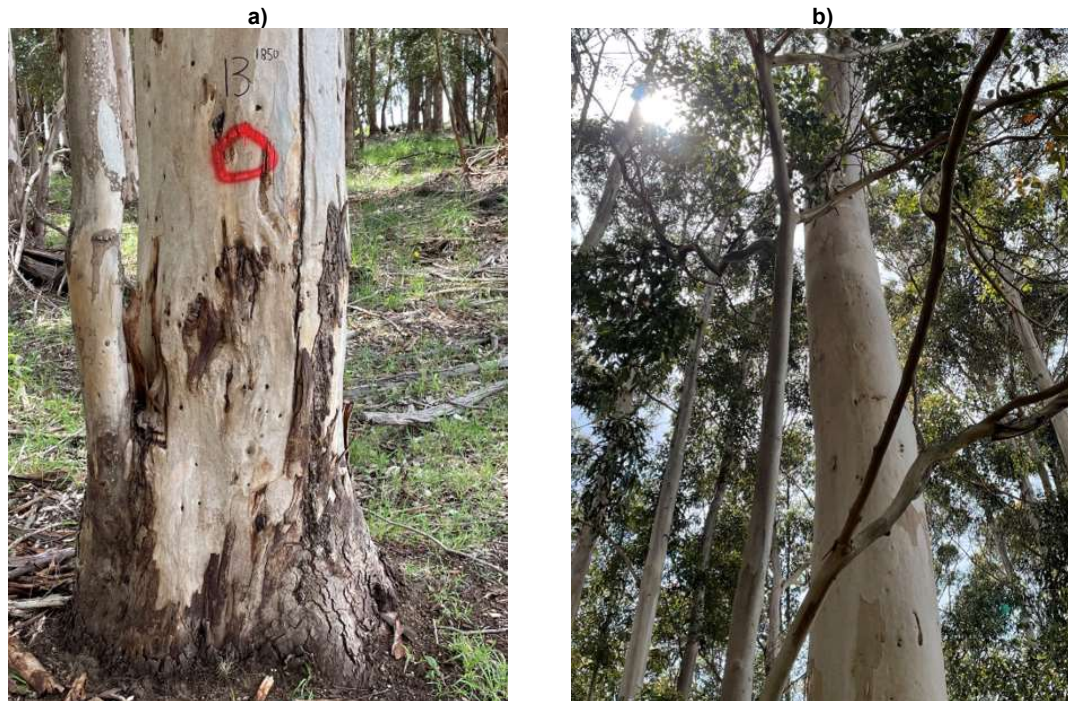


Figure 11(a-b). Photographs of Tree 13 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

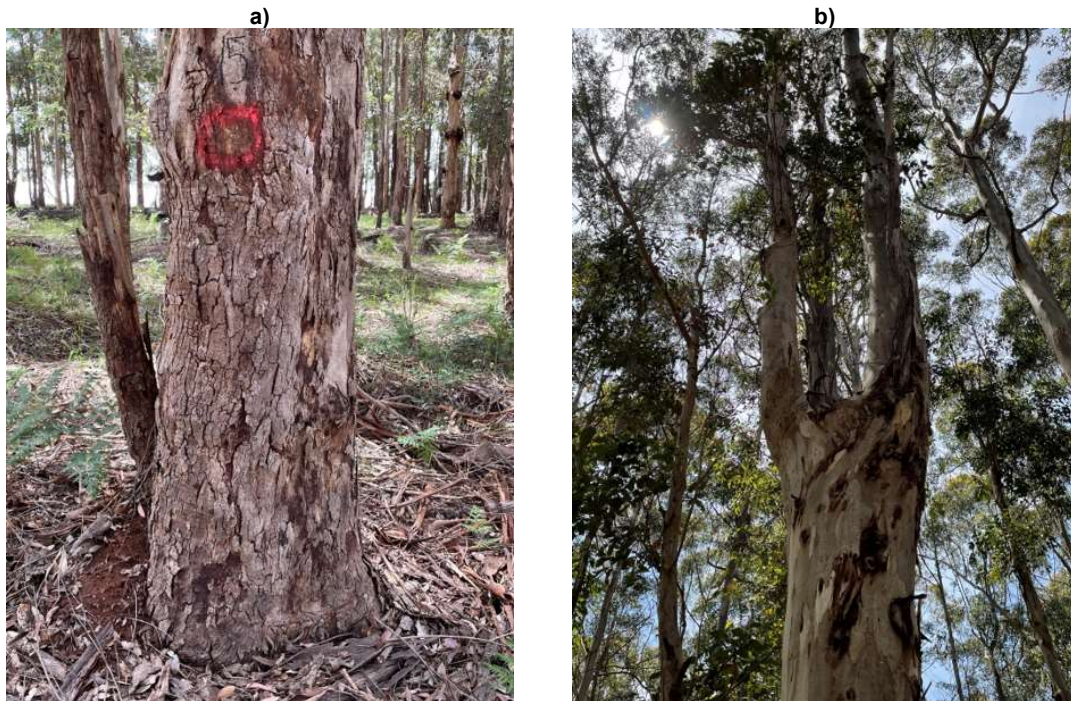


Figure 13(a-b). Photographs of Tree 15 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

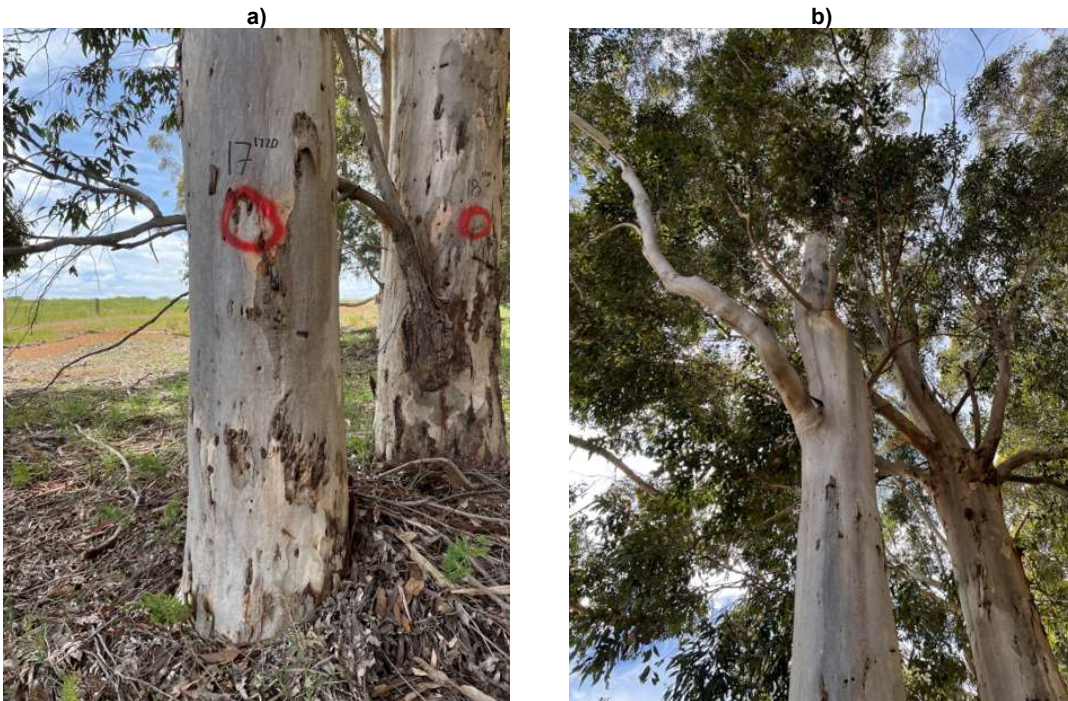


Figure 15(a-b). Photographs of Tree 17 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

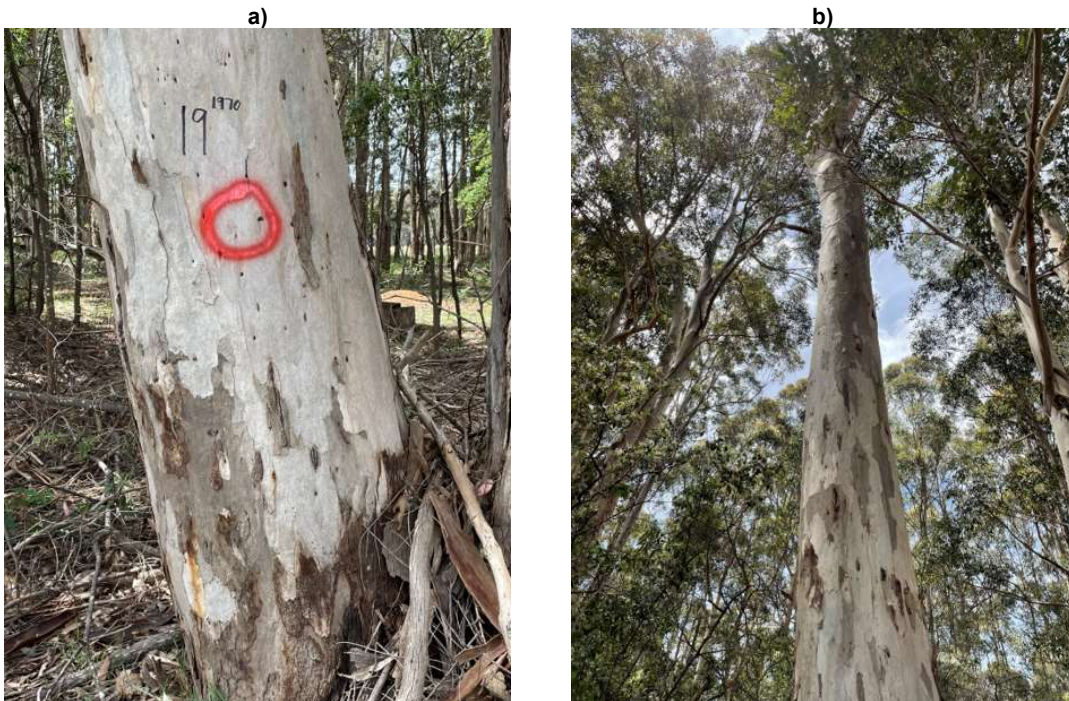


Figure 17(a-b). Photographs of Tree 19 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

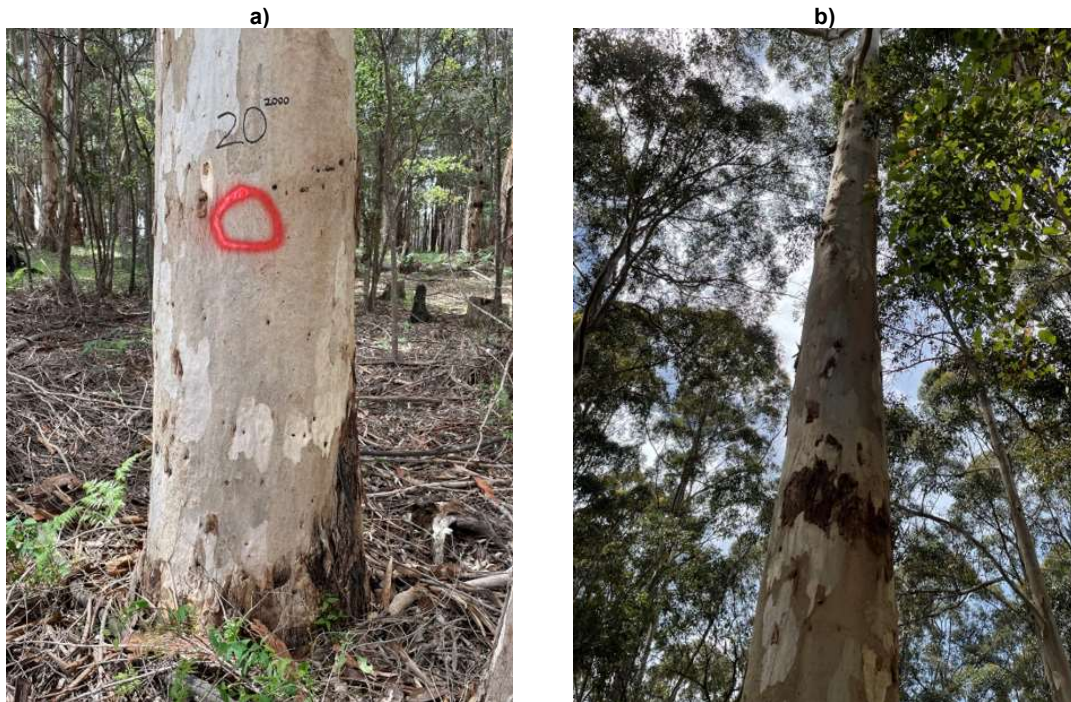


Figure 18(a-b). Photographs of Tree 20 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

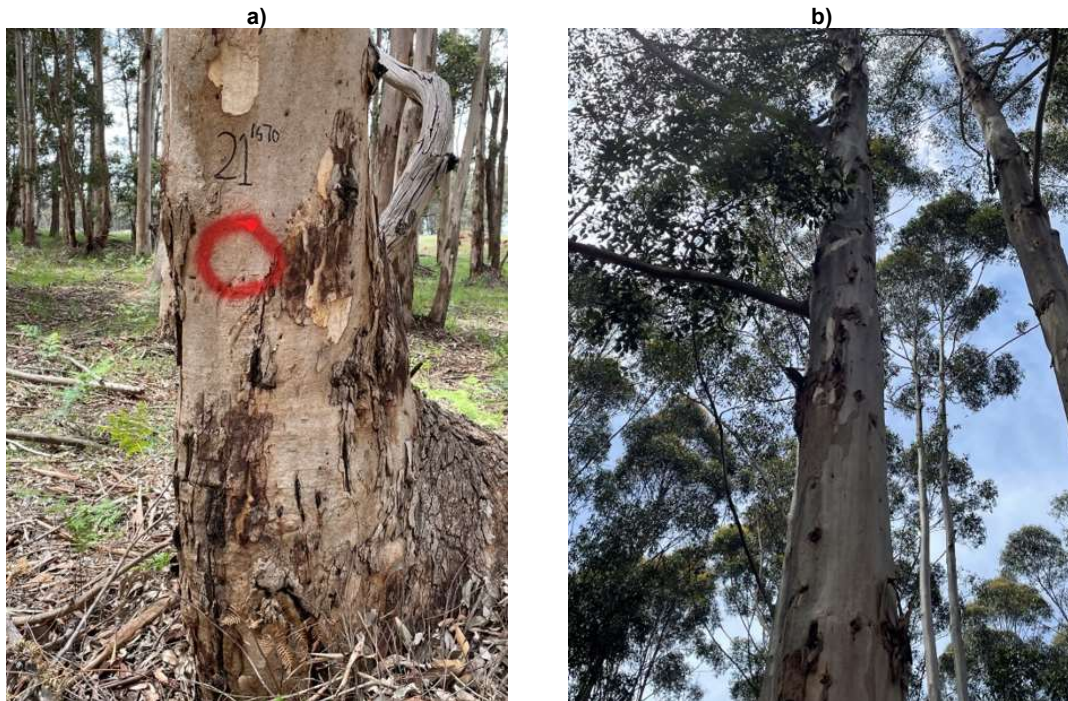


Figure 19(a-b). Photographs of Tree 21 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

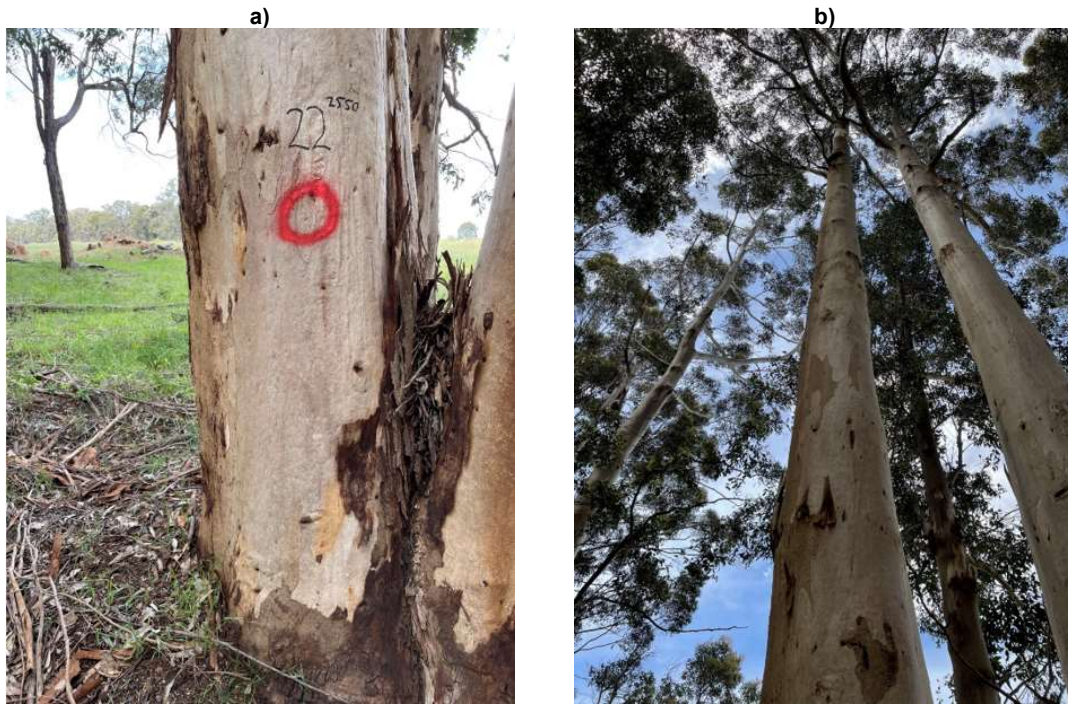


Figure 20(a-b). Photographs of Tree 22 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

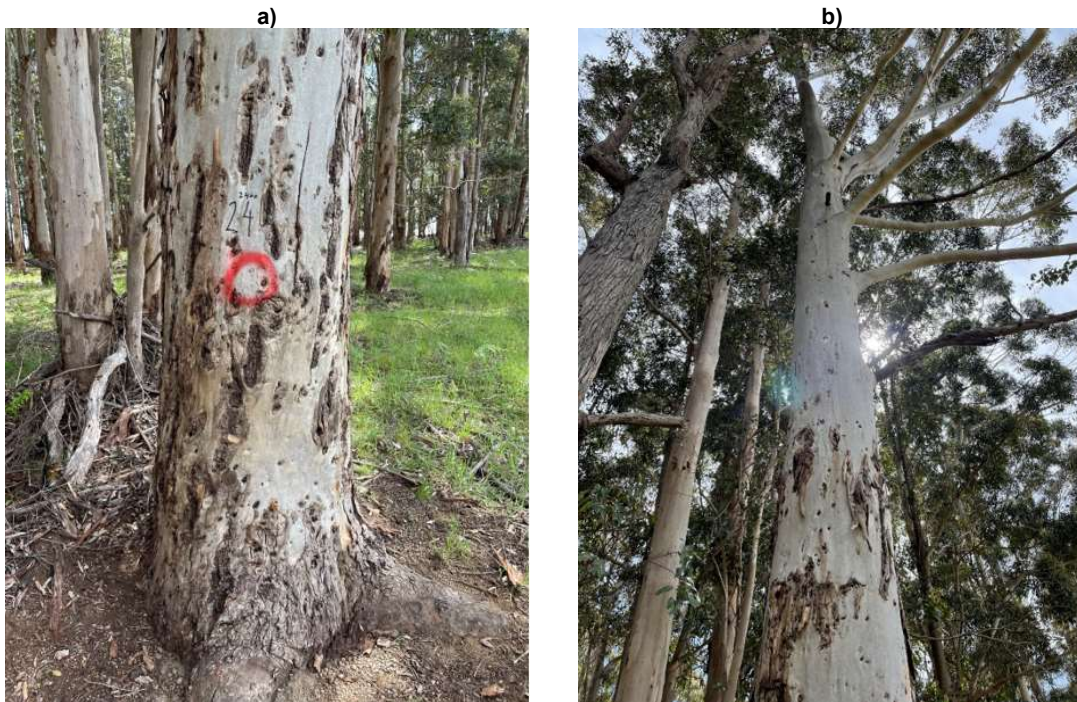


Figure 22(a-b). Photographs of Tree 214 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

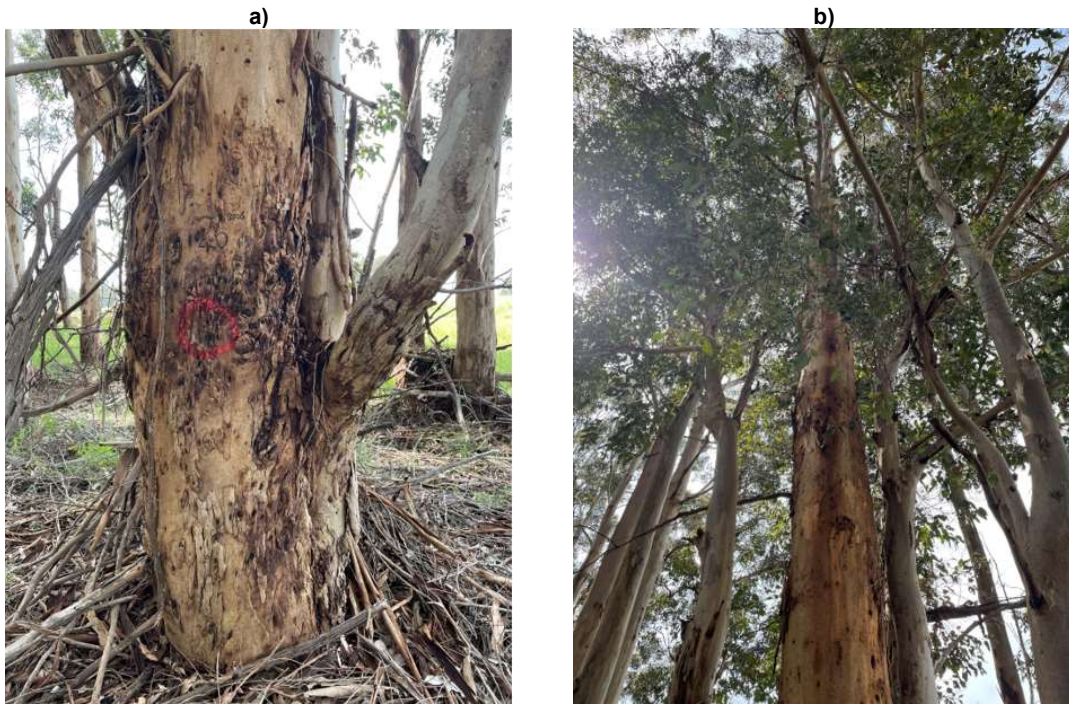


Figure 24(a-b). Photographs of Tree 26 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

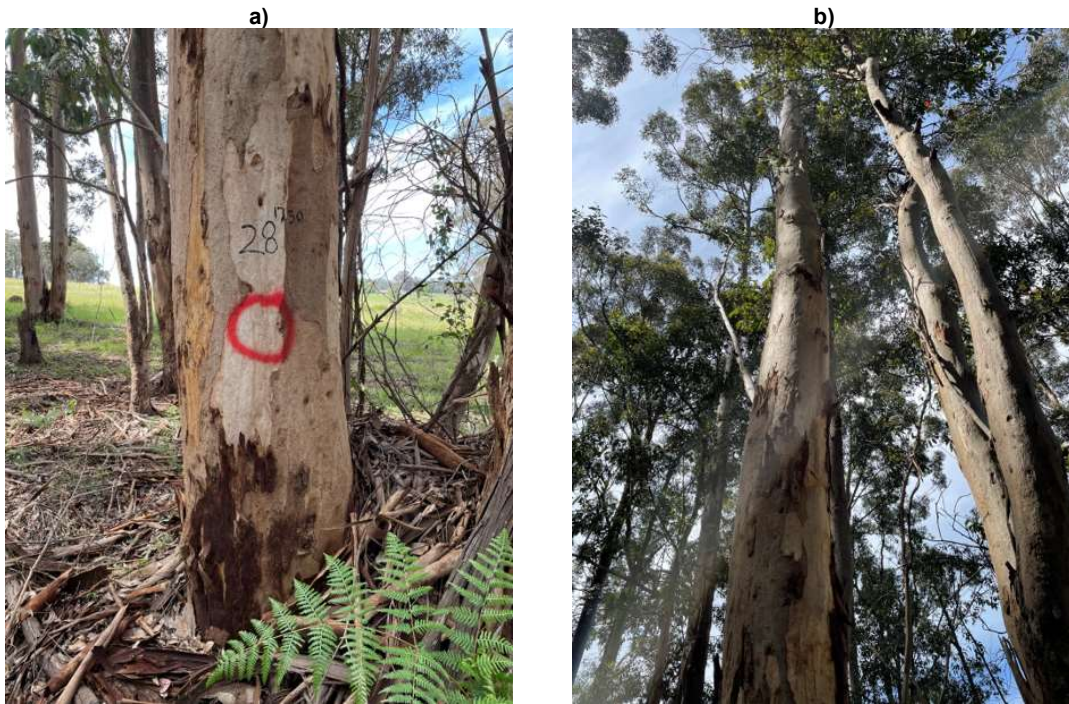


Figure 26(a-b). Photographs of Tree 28 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

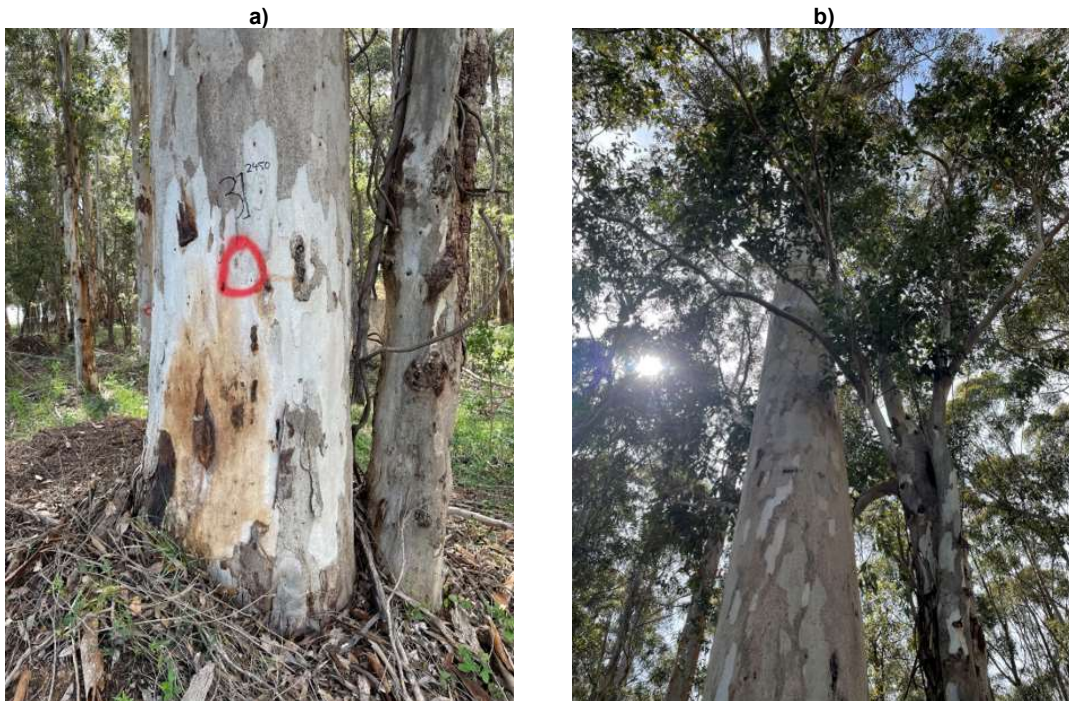


Figure 29(a-b). Photographs of Tree 31 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

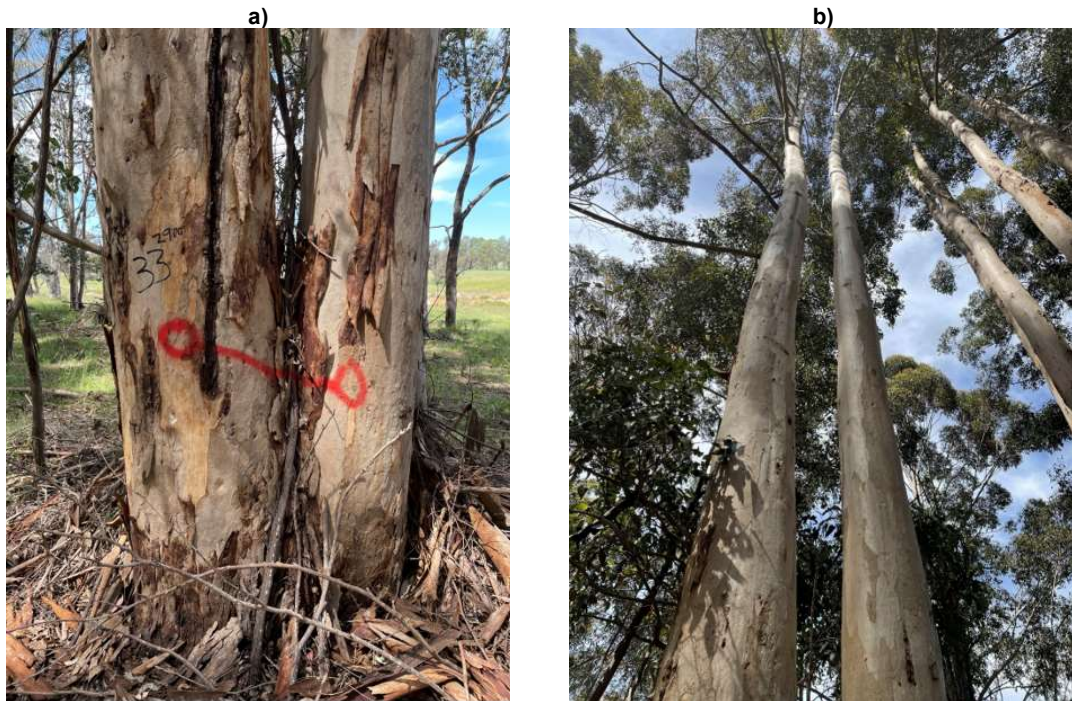


Figure 31(a-b). Photographs of Tree 33 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

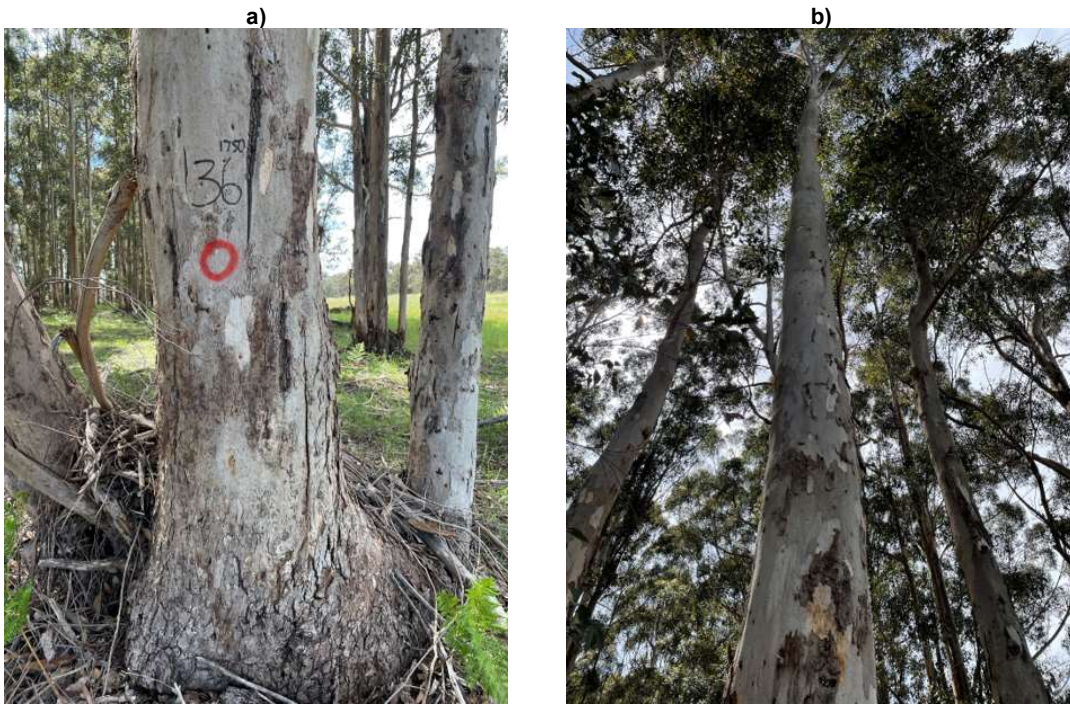


Figure 34(a-b). Photographs of Tree 36 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

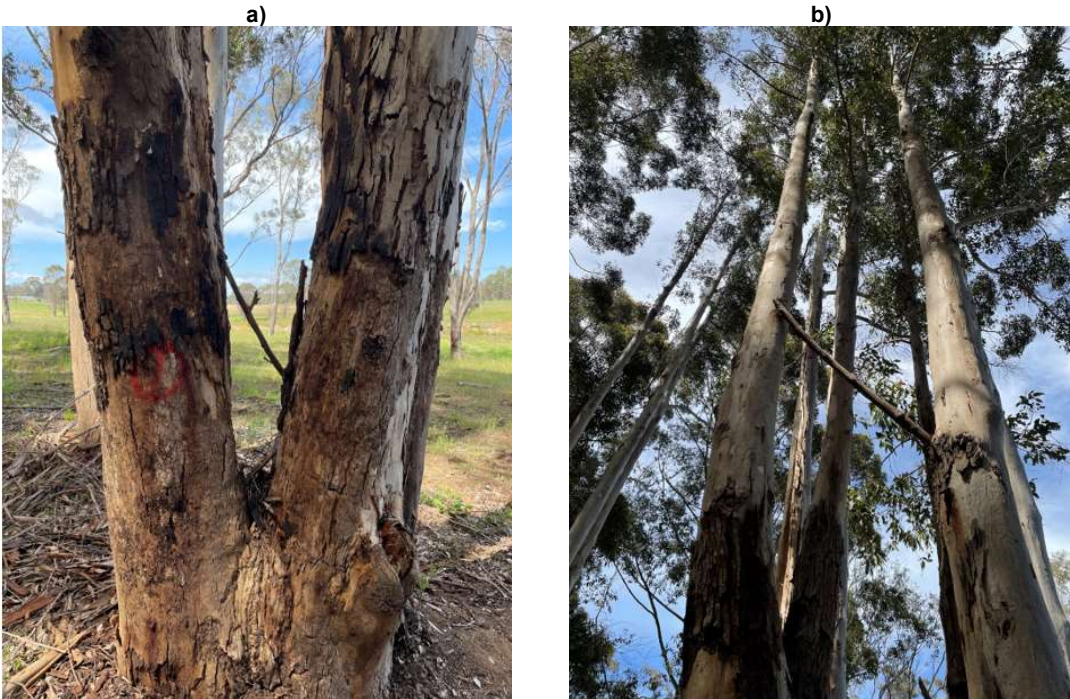


Figure 35(a-b). Photographs of Tree 37 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

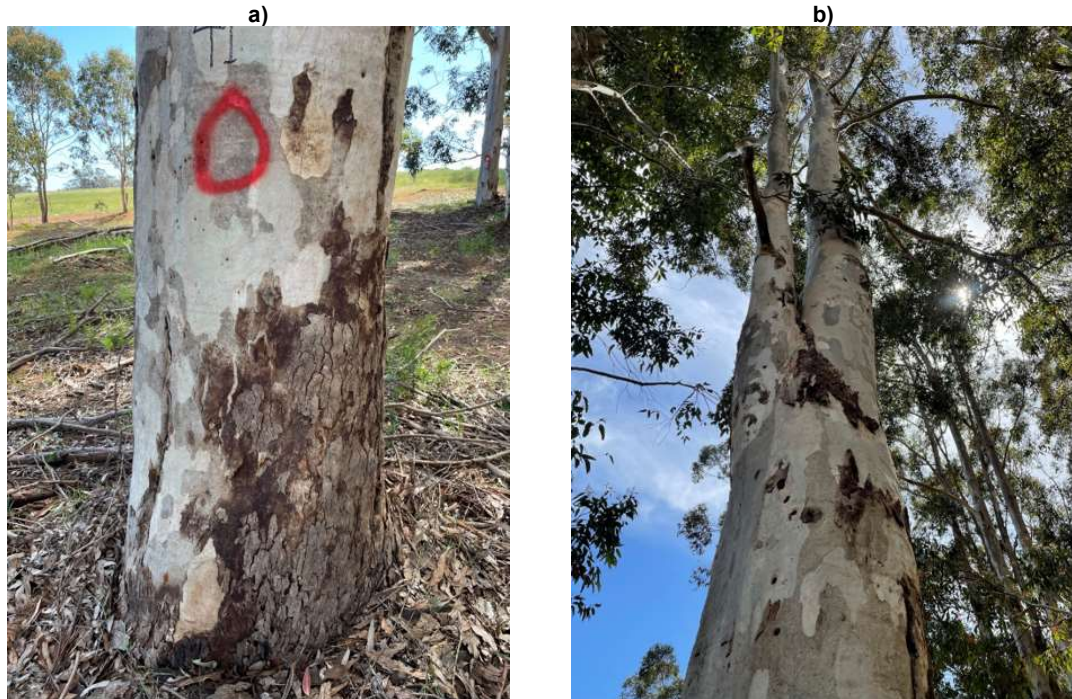


Figure 39(a-b). Photographs of Tree 41 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

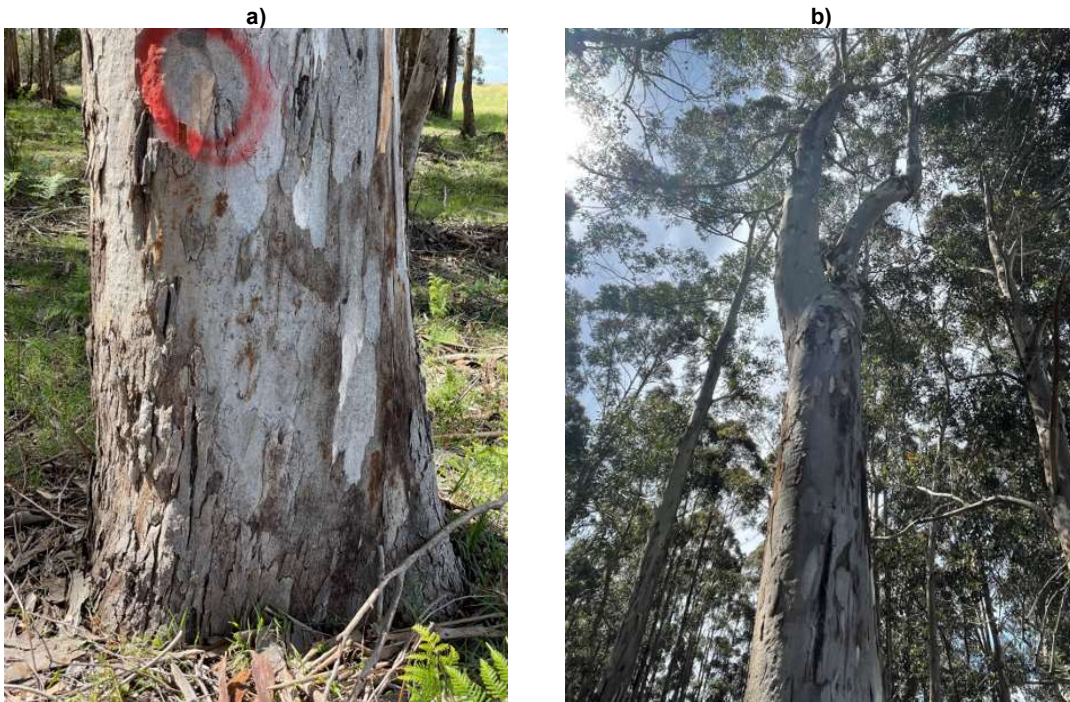


Figure 42(a-b). Photographs of Tree 44 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

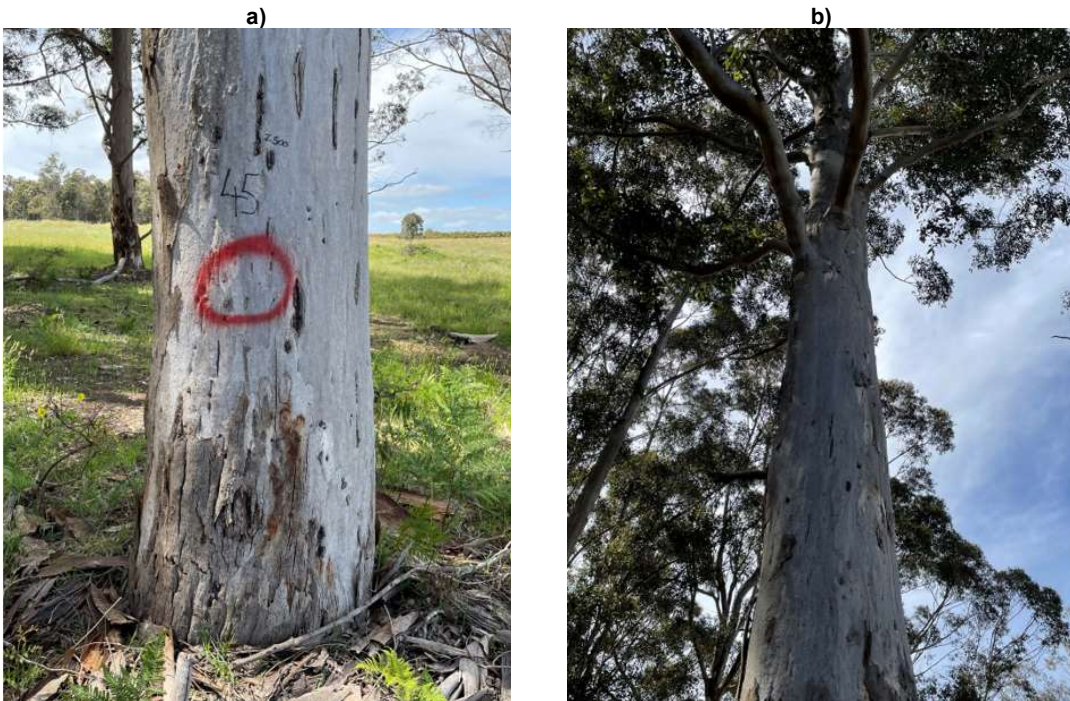


Figure 43(a-b). Photographs of Tree 45 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

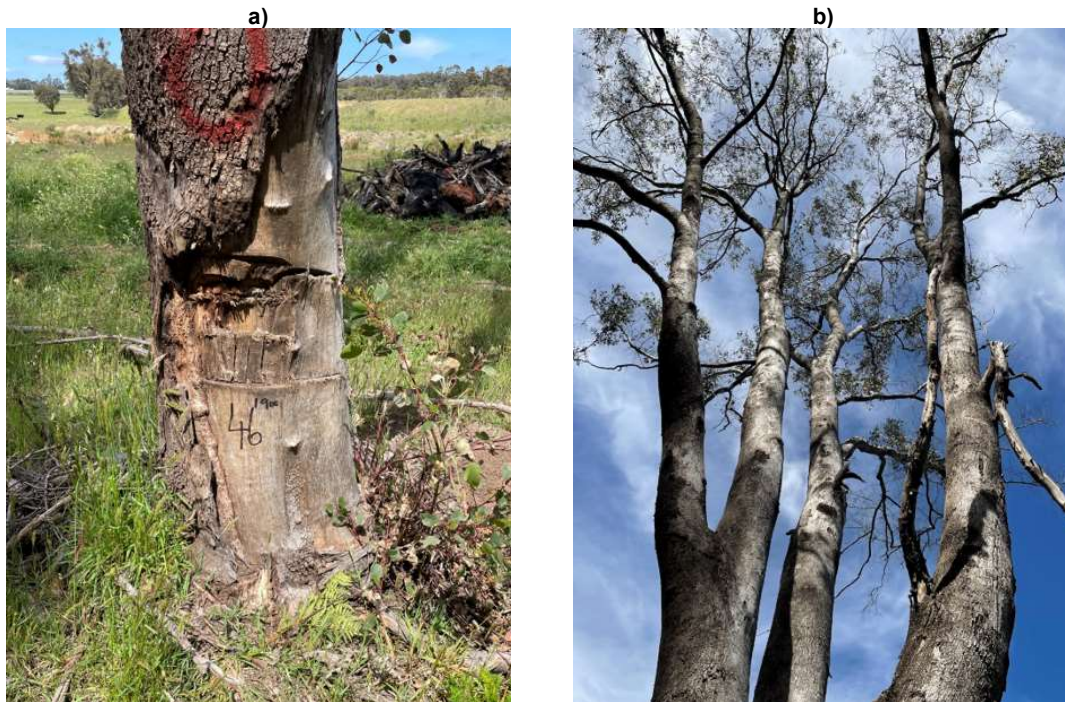


Figure 44(a-b). Photographs of Tree 46 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

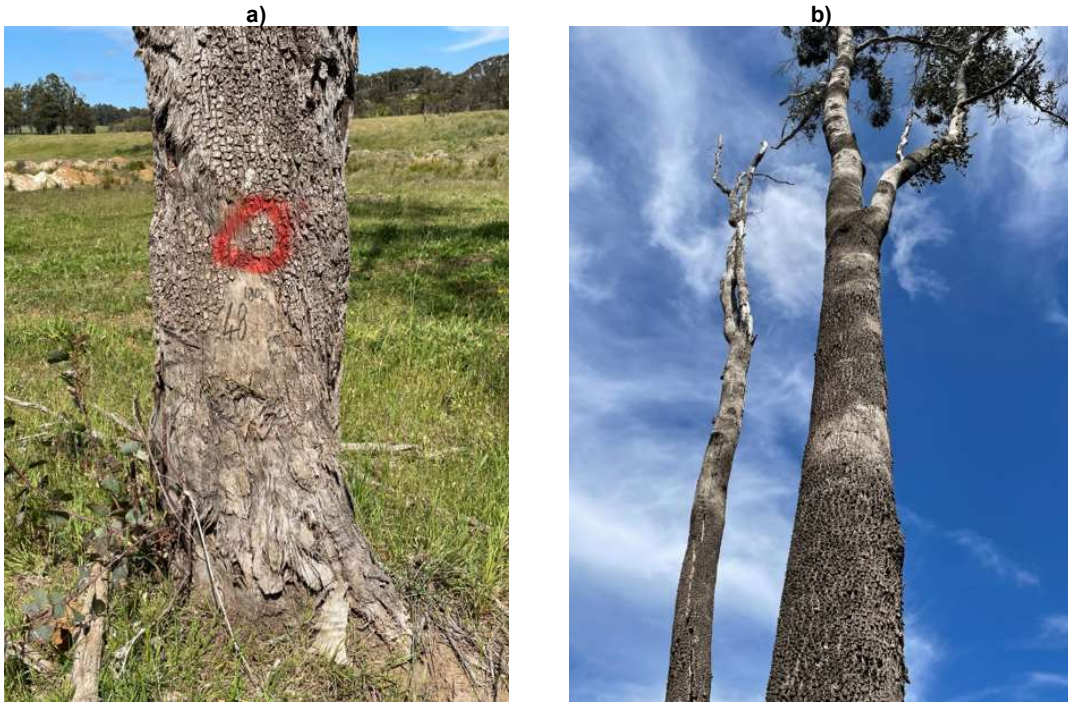


Figure 46(a-b). Photographs of Tree 48 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

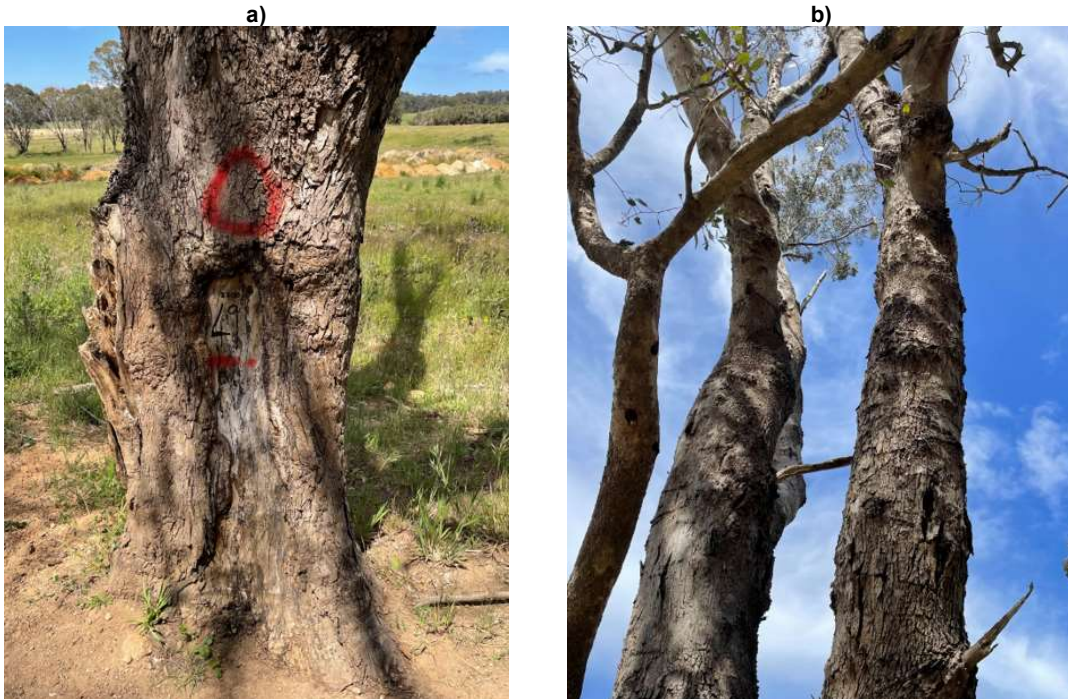


Figure 47(a-b). Photographs of Tree 49 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

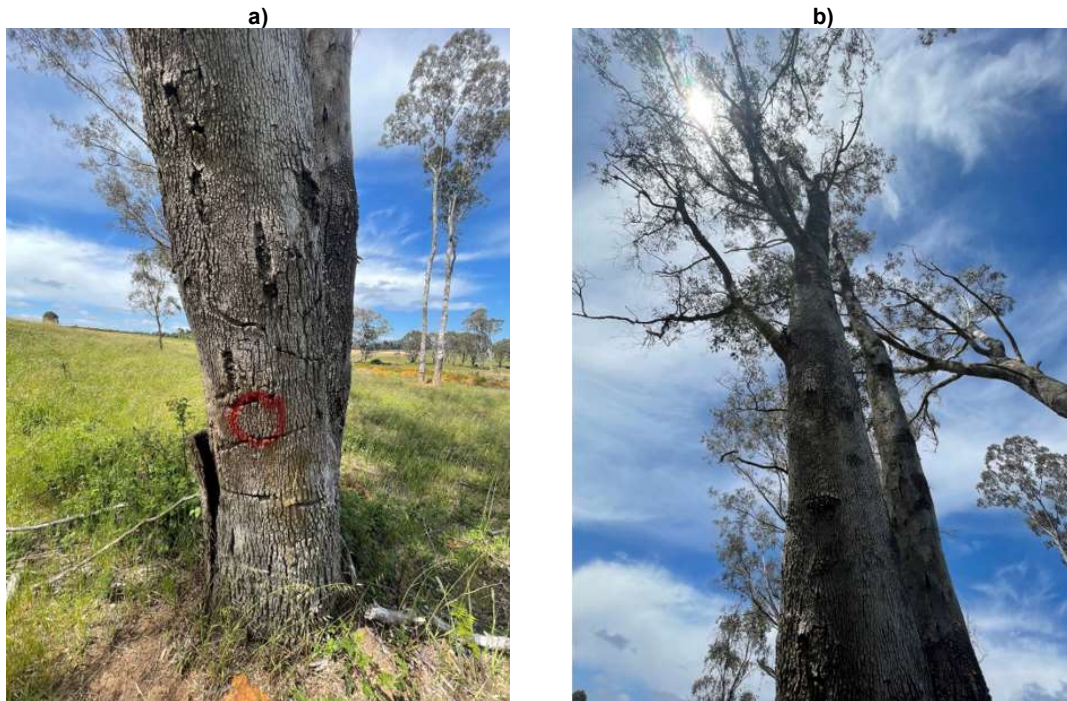


Figure 49(a-b). Photographs of Tree 51 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

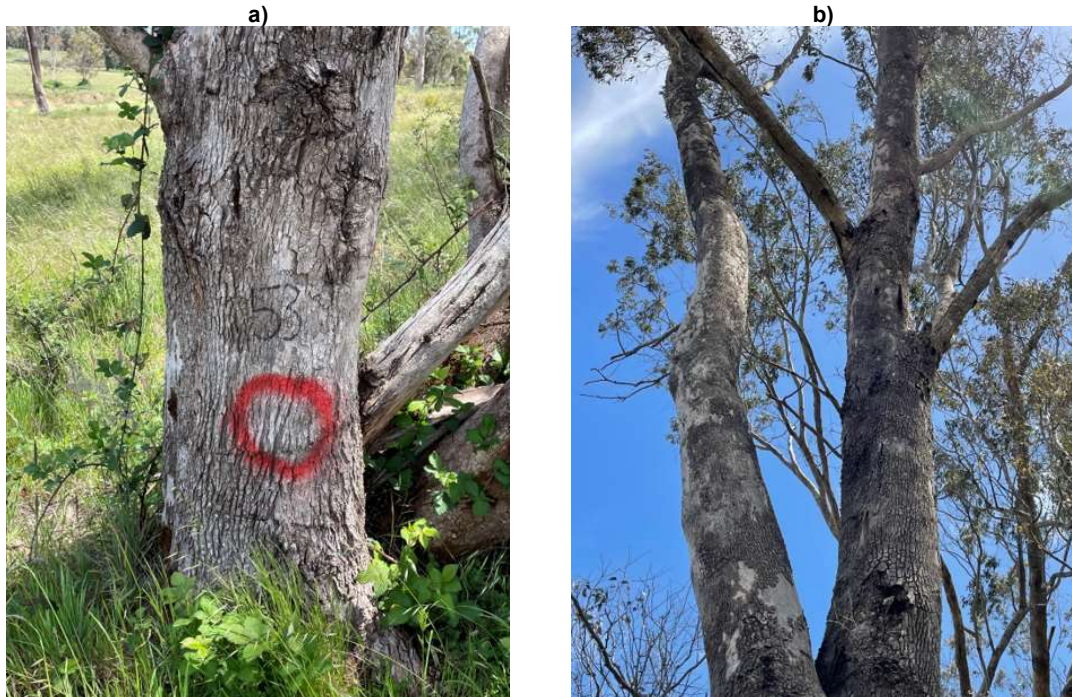


Figure 51(a-b). Photographs of Tree 53 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

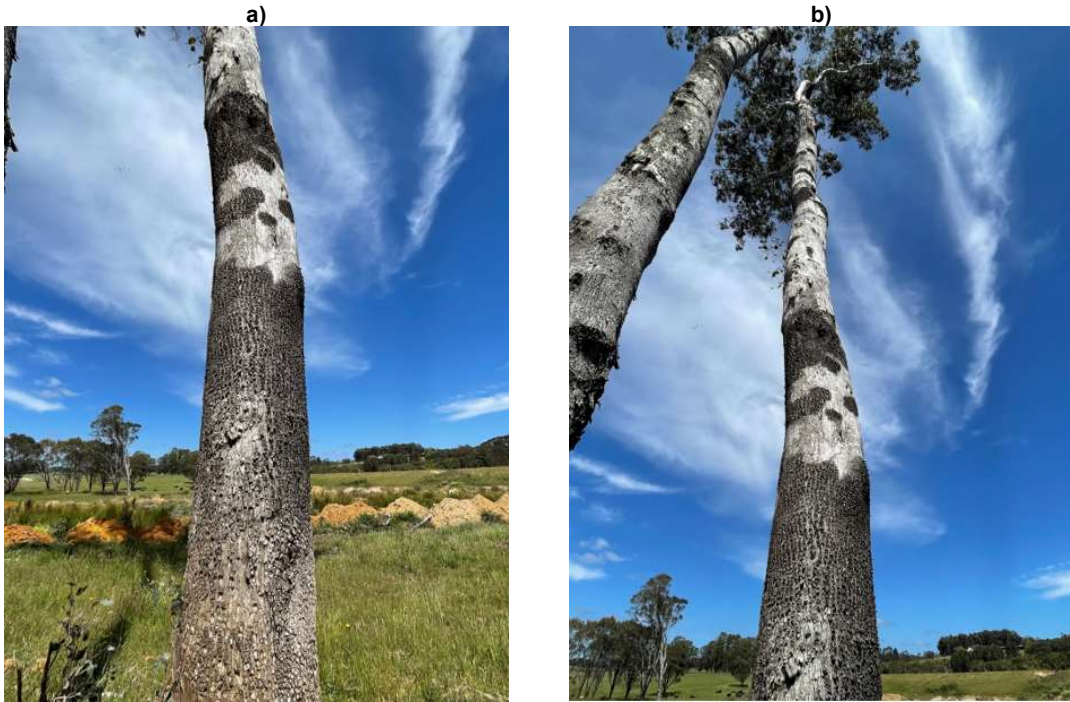


Figure 52(a-b). Photographs of Tree 54 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

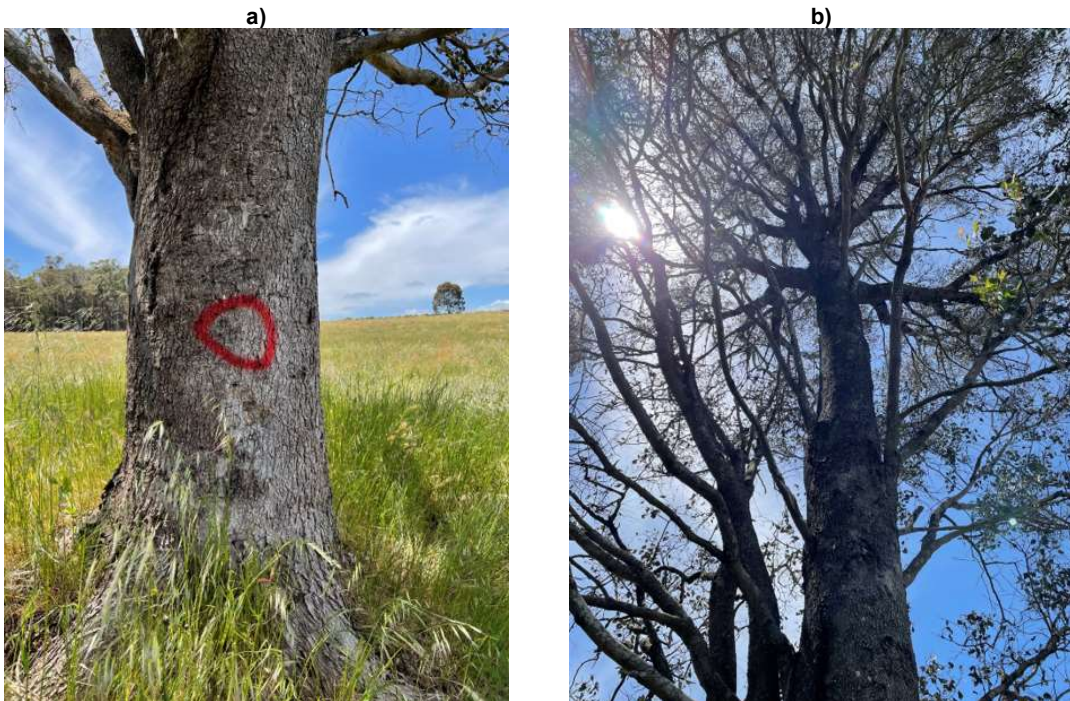


Figure 53(a-b). Photographs of Tree 55 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

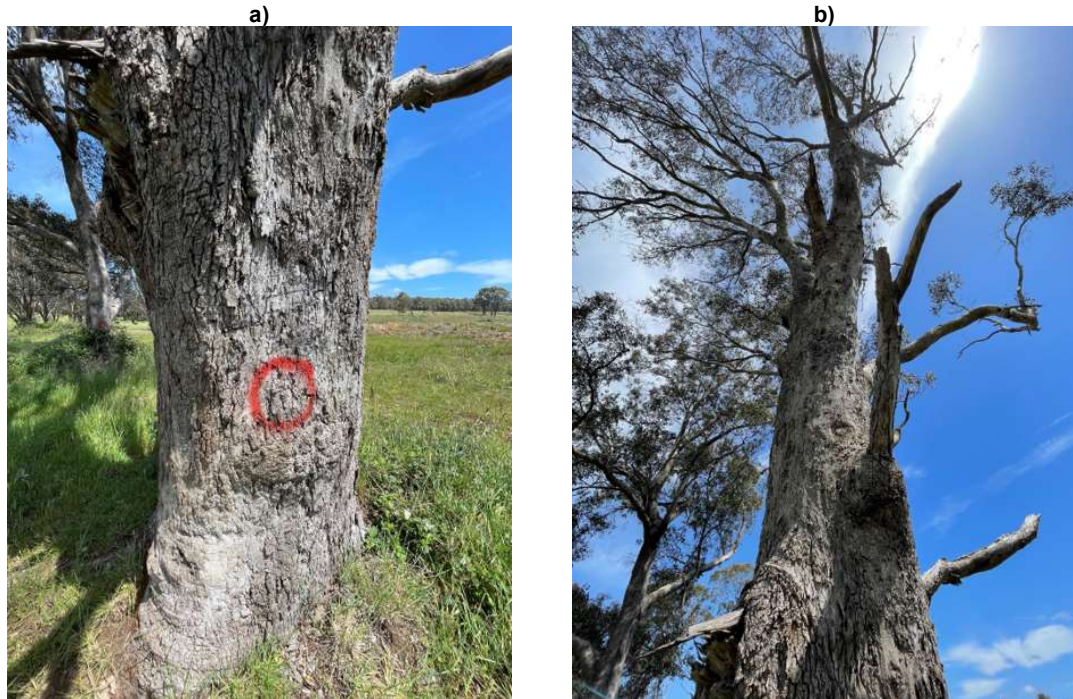


Figure 55(a-b). Photographs of Tree 57 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

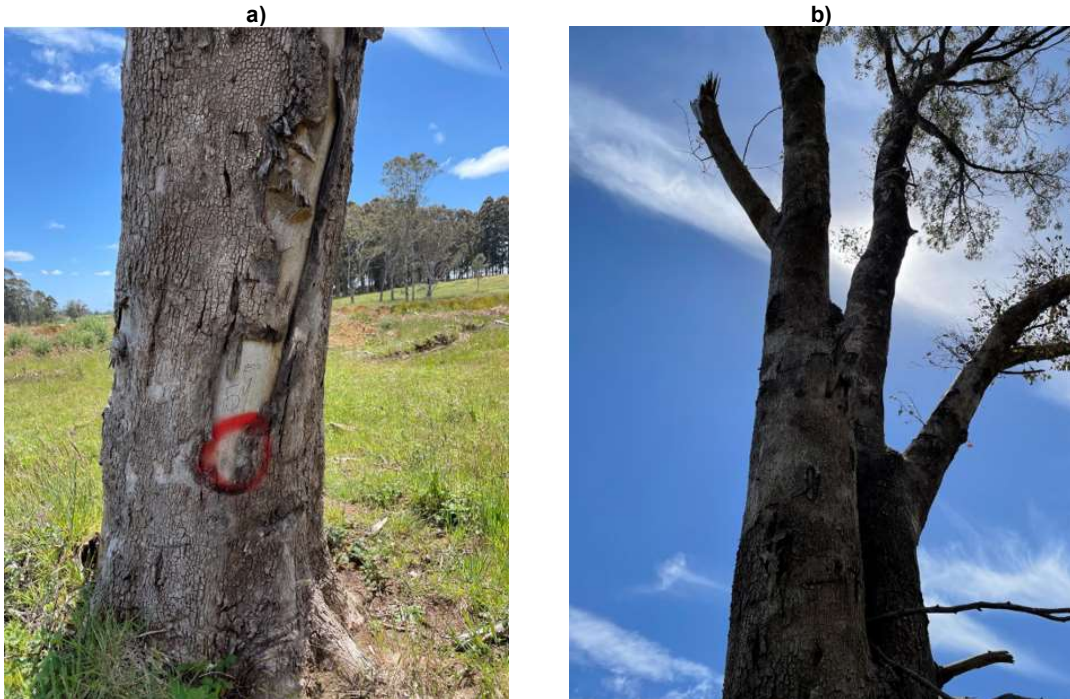


Figure 57(a-b). Photographs of Tree 59 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

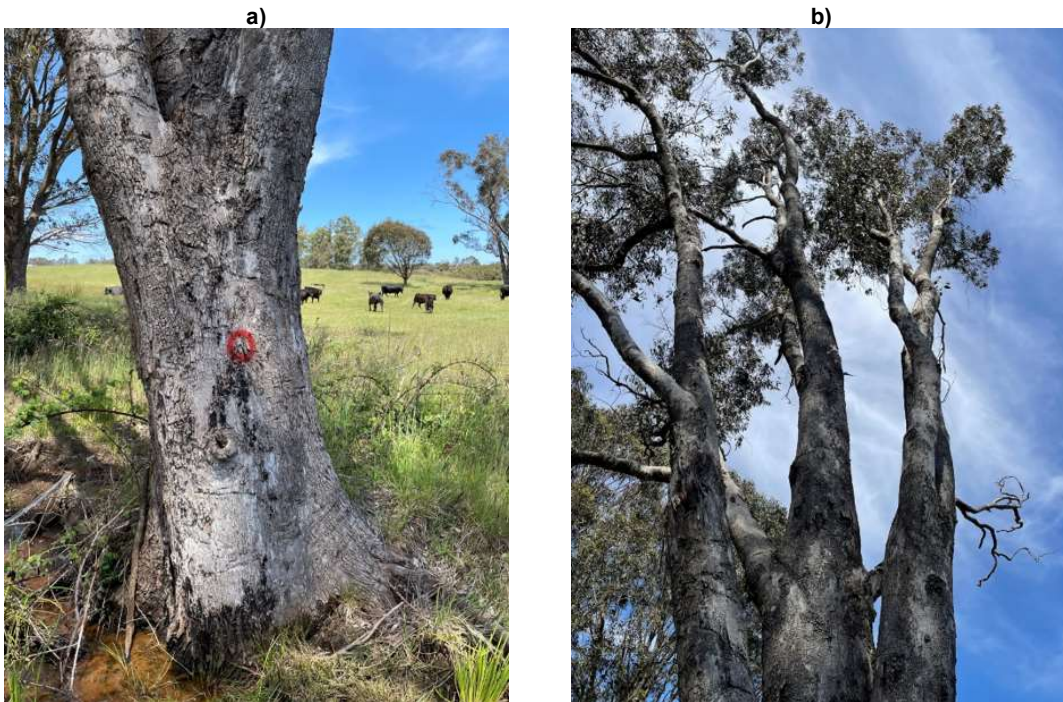


Figure 58(a-b). Photographs of Tree 60 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

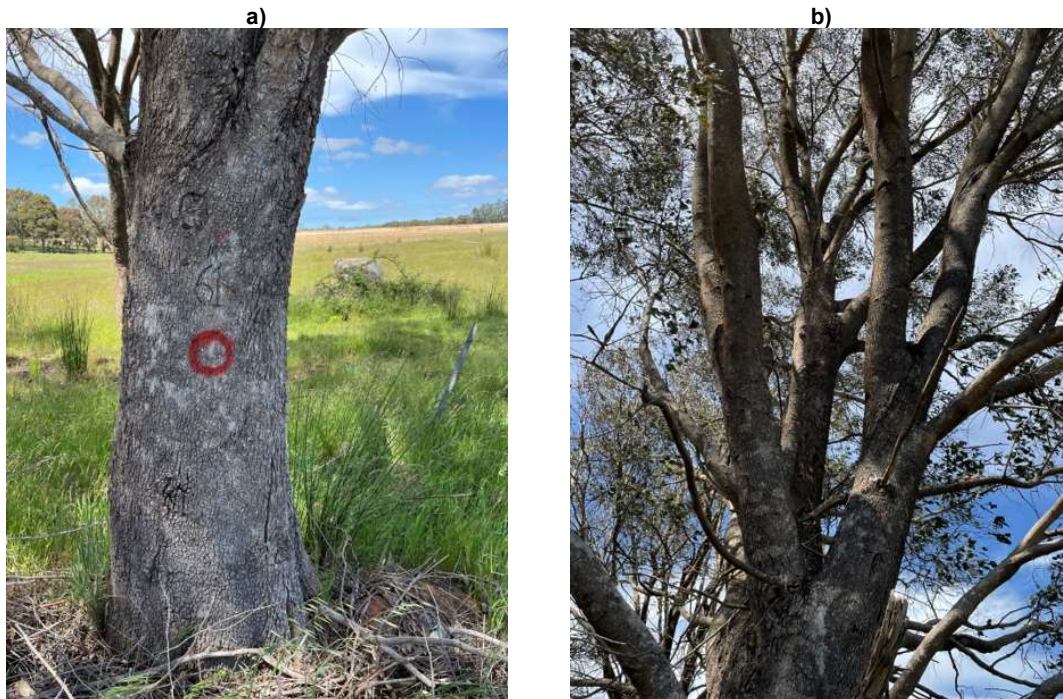


Figure 59 (a-b). Photographs of Tree 61 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).

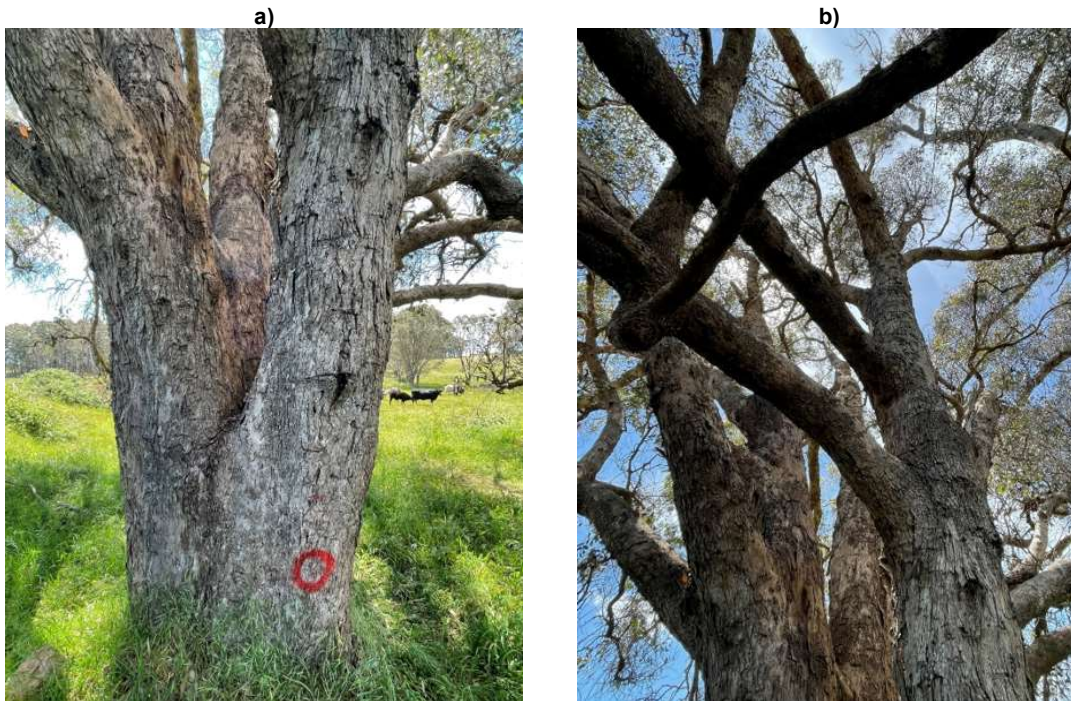


Figure 61(a-b). Photographs of Tree 63 within the proposed clearing area for CPS 9419/1 (Kuzich, 2021).
