Clearing of vegetation is necessary for the installation and maintenance of a buried high voltage power cable. A Clearing and Disturbance procedure is included as Attachment 5 and its first clearing principle includes a commitment to avoid the clearing of large trees unless absolutely necessary to implement the Project.
