# 3. Assessment of application against Clearing Principles

# (a) Native vegetation should not be cleared if it comprises a high level of biodiversity.

## Comments Proposal is not likely to be at variance to this Principle

The application area is located within the Pindanland subregion of the Dampierland Bioregion of the Interim Biogeographic Regionalisation for Australia (IBRA) (GIS Database). The Pindanland IBRA subregion comprises of sandplains of the Dampier Peninsula and western part of Dampier Land, including the hinterland of Eighty Mile Beach, and the vegetation is described primarily as Pindan (CALM, 2002).

The application area is wholly comprised of Beard vegetation association 750 (GIS Database). Greater than 99% of the pre-European extent of this association remains within the Dampierland bioregion (Government of Western Australia, 2015). Therefore the area proposed to be cleared does not represent a significant remnant of native vegetation within an area that has been extensively cleared.

The application area does not fall within the boundaries of any Priority Ecological Communities (PEC), however is within the buffer zone of the Mangarr (Minyjuru) Threatened Ecological Community (TEC) (GIS Database). The Mangarr (Minyjuru) TEC is located approximately 1.6 kilometres east of the application area and is unlikely to be impacted by the proposed clearing activities (GIS Database).

A flora and vegetation survey was undertaken over Mining Lease 04/461 by EcOz Environmental Consultants in June 2016 (EcOz, 2016). No Threatened or Priority flora were recorded during the survey.

A fauna survey was undertaken by EcOz Environmental Consultants in June 2016 (EcOz, 2016). No Threatened or Priority fauna were recorded during the survey (EcOz, 2016).

Several weed species have the potential to occur within the application area. Weeds have the potential to outcompete native flora and reduce the biodiversity of an area. Potential impacts to biodiversity as a result of the proposed clearing may be minimised by the implementation of a weed management condition.

The vegetation associations, fauna habitats and landform types present within the application area, are well represented in surrounding areas (EcOz, 2016; GIS Database). The application area is unlikely to represent an area of higher biodiversity than surrounding areas, in either a local or regional context.

Based on the above, the proposed clearing is not likely to be at variance to this Principle.

# (b) Native vegetation should not be cleared if it comprises the whole or a part of, or is necessary for the maintenance of, a significant habitat for fauna.

## Comments Proposal may be at variance to this Principle

A fauna survey was undertaken over Mining Lease 04/461 by EcOz Environmental Consultants in June 2016 (EcOz, 2016).

The habitat within the application area is described as 'Pindan woodland.'

Nineteen fauna species were recorded during the fauna survey, comprised of 18 bird species and one mammal (EcOz, 2016). None of these species were of conservation significance (EcOz, 2016).

The application area falls within current known distributions of the Greater Bilby (EcOz, 2016). There are records surrounding the application area, including in areas of disturbance such as road verges and soil heaps (DPaW, 2016). However, no burrows, diggings or other signs of the Greater Bilby were identified during the survey (EcOz, 2016). Greater Bilbies are highly mobile species known to use burrows over two kilometres apart on consecutive days and have a home range size from one kilometre to over three square kilometres (Pavey, 2006). As there is the potential for Bilby to utilise the area for foraging, it is recommended that a fauna management condition be placed on the permit requiring slow progressive clearing towards surrounding remnant vegetation to allow fauna to escape the clearing activity.

The habitat type within the application area may provide suitable foraging habitat for the Peregrine Falcon (*Falco peregrinus*) and the Grey Falcon (*Falco hypoleucos*) (GIS Database). There are also several migratory birds that may utilise the application area for foraging as part of a wider distribution (EcOz, 2016). Given that these species are highly mobile avian species and noting the extensive vegetation remaining in the local area

that could provide suitable foraging habitat in similar or better condition (GIS Database), the proposed clearing is not likely to significantly impact on the conservation status of avian species or their habitat.

Based on the above, the proposed clearing may be at variance to this Principle.

# (c) Native vegetation should not be cleared if it includes, or is necessary for the continued existence of, threatened flora.

### Comments Proposal is not likely to be at variance to this Principle

There are no known records of Threatened flora within the application area (GIS Database). A flora survey of the application area did not record any species of Threatened flora (EcOz, 2016).

The vegetation associations within the application area are common and widespread within the region (EcOz, 2016; GIS Database), and the vegetation proposed to be cleared is unlikely to be necessary for the continued existence of any species of Threatened flora.

Based on the above, the proposed clearing is not likely to be at variance to this Principle.

# (d) Native vegetation should not be cleared if it comprises the whole or a part of, or is necessary for the maintenance of a threatened ecological community.

# Comments Proposal is not likely to be at variance to this Principle

There are no known Threatened Ecological Communities (TECs) located within the application area (GIS Database). The Mangarr (Minyjuru) TEC is located approximately 1.6 kilometres east of the application area. This TEC is described as "Relict dune system dominated by extensive stands of Minyjuru (Mangarr) Sersalisia (formerly Pouteria) sericea" (GIS Database). It is considerd unlikely that the proposed clearing activities will have any impact on the values of this TEC.

A flora and vegetation survey of the application area did not identify any TECs (EcOz, 2016).

Based on the above, the proposed clearing is not likely to be at variance to this Principle.

# (e) Native vegetation should not be cleared if it is significant as a remnant of native vegetation in an area that has been extensively cleared.

# Comments Proposal is not at variance to this Principle

The application area falls within the Dampierland Bioregion of the Interim Biogeographic Regionalisation for Australia (GIS Database). Approximately 99.68% of the pre-European vegetation still exists in the Dampierland Bioregion (Government of Western Australia, 2019).

The application area is broadly mapped as Beard vegetation association 750 (GIS Database). This vegetation association has not been extensively cleared as over 99% of the pre-European extent of this vegetation association remains uncleared at both the state and bioregional level (Government of Western Australia, 2019).

The permit area does not contain any remnants nor does it form part of any remnants in the local area (GIS Database).

Based on the above, the proposed clearing is not at variance to this Principle.

# (f) Native vegetation should not be cleared if it is growing in, or in association with, an environment associated with a watercourse or wetland.

# Comments Proposal is at variance to this Principle

There are no watercourses or wetlands within the area proposed to clear (EcOz, 2016; GIS Database).

Based on the above, the proposed clearing is not at variance to this Principle.

# (g) Native vegetation should not be cleared if the clearing of the vegetation is likely to cause appreciable land degradation.

## Comments Proposal is not likely to be at variance to this Principle

The application area lies within the Wanganut land system (GIS Database). This land system has been mapped and described in technical bulletins produced by the former Department of Agriculture (now the Department of Primary Industries and Regional Development).

The Wanganut land system is described as sandplains and dunes with pindan woodlands and spinifex/tussock grasslands. This land system is not generally susceptible to degradation or erosion (Payne & Schoknecht, 2011).

The proposed clearing of up to 10.7 hectares of native vegetation is unlikely to cause appreciable land degradation.

Based on the above, the proposed clearing is not likely to be at variance to this Principle.

# (h) Native vegetation should not be cleared if the clearing of the vegetation is likely to have an impact on the environmental values of any adjacent or nearby conservation area.

## Comments Proposal is not likely to be at variance to this Principle

There are no conservation areas within the application area. The nearest DBCA (formerly DPaW) managed land is an un-named Nature Reserve which is located approximately 300 metres north of the application area (GIS Database). The proposed clearing is unlikely to impact on the environmental values of any conservation area.

Based on the above, the proposed clearing is not likely to be at variance to this Principle.

# (i) Native vegetation should not be cleared if the clearing of the vegetation is likely to cause deterioration in the quality of surface or underground water.

## Comments Proposal is not likely to be at variance to this Principle

There are no Public Drinking Water Source Areas within or in close proximity to the application area (GIS Database). There are no watercourses or wetlands within the area proposed to clear (GIS Database). The proposed clearing is unlikely to result in significant changes to surface water flows.

The proposed clearing is unlikely to cause deterioration in the quality of underground water.

Based on the above, the proposed clearing is not likely to be at variance to this Principle.

# (j) Native vegetation should not be cleared if clearing the vegetation is likely to cause, or exacerbate, the incidence or intensity of flooding.

# Comments Proposal is not likely to be at variance to this Principle

The climate of the region is dry hot tropical and semi-arid with summer rainfall, with a low average rainfall of approximately 623.5 millimetres per year (BoM, 2022).

There are no watercourses or waterbodies within the application area (GIS Database). Seasonal drainage lines are common in the region and temporary localised flooding may occur briefly following heavy rainfall events. However, the proposed clearing is unlikely to increase the incidence or intensity of natural flooding events.

Based on the above, the proposed clearing is not likely to be at variance to this Principle.

# Planning Instrument, Native Title, previous EPA decision or other matter.

#### Comments

The clearing permit application was advertised on 10 December 2021 by the Department of Mines, Industry Regulation and Safety (DMIRS), inviting submissions from the public. No submissions were received in relation to this application.

There is one native title claim over the area under application (DPLH, 2022). This claim has been determined by the Federal Court on behalf of the claimant group. However, the mining tenure has been granted in accordance with the future act regime of the *Native Title Act 1993* and the nature of the act (i.e. the proposed clearing activity) has been provided for in that process, therefore, the granting of a clearing permit is not a future act under the *Native Title Act 1993*.

There are no registered Aboriginal Sites of Significance within the application area (DPLH, 2022). It is the proponent's responsibility to comply with the *Aboriginal Heritage Act 1972* and ensure that no Aboriginal Sites of Significance are damaged through the clearing process.

It is the proponent's responsibility to liaise with the Department of Water and Environmental Regulation and the Department of Biodiversity, Conservation and Attractions, to determine whether a Works Approval, Water Licence, Bed and Banks Permit, or any other licences or approvals are required for the proposed works.

# **Definitions:**

{DBCA (2019) Conservation Codes for Western Australian Flora and Fauna. Department of Biodiversity, Conservation and Attractions, Western Australia}:-

## T <u>Threatened species:</u>

Listed by order of the Minister as Threatened in the category of critically endangered, endangered or vulnerable under section 19(1), or is a rediscovered species to be regarded as threatened species under section 26(2) of the *Biodiversity Conservation Act 2016* (BC Act).

**Threatened fauna** is that subset of 'Specially Protected Fauna' listed under schedules 1 to 3 of the *Wildlife Conservation (Specially Protected Fauna) Notice 2018* for Threatened Fauna.

**Threatened flora** is that subset of 'Rare Flora' listed under schedules 1 to 3 of the *Wildlife* Conservation (Rare Flora) Notice 2018 for Threatened Flora.

The assessment of the conservation status of these species is based on their national extent and ranked according to their level of threat using IUCN Red List categories and criteria as detailed below.

## CR Critically endangered species

Threatened species considered to be "facing an extremely high risk of extinction in the wild in the immediate future, as determined in accordance with criteria set out in the ministerial guidelines".

Listed as critically endangered under section 19(1)(a) of the BC Act in accordance with the criteria set out in section 20 and the ministerial guidelines. Published under schedule 1 of the *Wildlife Conservation (Specially Protected Fauna) Notice 2018* for critically endangered fauna or the *Wildlife Conservation (Rare Flora) Notice 2018* for critically endangered flora.

## EN Endangered species

Threatened species considered to be "facing a very high risk of extinction in the wild in the near future, as determined in accordance with criteria set out in the ministerial guidelines".

Listed as endangered under section 19(1)(b) of the BC Act in accordance with the criteria set out in section 21 and the ministerial guidelines. Published under schedule 2 of the *Wildlife Conservation* (Specially Protected Fauna) Notice 2018 for endangered fauna or the *Wildlife Conservation* (Rare Flora) Notice 2018 for endangered flora.

## Vulnerable species

Threatened species considered to be "facing a high risk of extinction in the wild in the medium-term future, as determined in accordance with criteria set out in the ministerial guidelines".

Listed as vulnerable under section 19(1)(c) of the BC Act in accordance with the criteria set out in section 22 and the ministerial guidelines. Published under schedule 3 of the *Wildlife Conservation* (Specially Protected Fauna) Notice 2018 for vulnerable fauna or the *Wildlife Conservation* (Rare Flora) Notice 2018 for vulnerable flora.

### **Extinct Species:**

## EX Extinct species

Species where "there is no reasonable doubt that the last member of the species has died", and listing is otherwise in accordance with the ministerial guidelines (section 24 of the BC Act).

Published as presumed extinct under schedule 4 of the *Wildlife Conservation (Specially Protected Fauna)* Notice 2018 for extinct fauna or the *Wildlife Conservation (Rare Flora)* Notice 2018 for extinct flora.

## EW Extinct in the wild species

Species that "is known only to survive in cultivation, in captivity or as a naturalised population well outside its past range; and it has not been recorded in its known habitat or expected habitat, at appropriate seasons, anywhere in its past range, despite surveys over a time frame appropriate to its life cycle and form", and listing is otherwise in accordance with the ministerial guidelines (section 25 of the BC Act).

Currently there are no threatened fauna or threatened flora species listed as extinct in the wild. If listing of a species as extinct in the wild occurs, then a schedule will be added to the applicable notice.

#### Specially protected species:

Listed by order of the Minister as specially protected under section 13(1) of the BC Act. Meeting one or more of the following categories: species of special conservation interest; migratory species; cetaceans; species subject to international agreement; or species otherwise in need of special protection.

Species that are listed as threatened species (critically endangered, endangered or vulnerable) or extinct species under the BC Act cannot also be listed as Specially Protected species.

### MI Migratory species

Fauna that periodically or occasionally visit Australia or an external Territory or the exclusive economic zone; or the species is subject of an international agreement that relates to the protection of migratory species and that binds the Commonwealth; and listing is otherwise in accordance with the ministerial guidelines (section 15 of the BC Act).

Includes birds that are subject to an agreement between the government of Australia and the governments of Japan (JAMBA), China (CAMBA) and The Republic of Korea (ROKAMBA), and fauna subject to the *Convention on the Conservation of Migratory Species of Wild Animals* (Bonn Convention), an environmental treaty under the United Nations Environment Program. Migratory species listed under the BC Act are a subset of the migratory animals, that are known to visit Western Australia, protected under the international agreements or treaties, excluding species that are listed as Threatened species.

Published as migratory birds protected under an international agreement under schedule 5 of the *Wildlife Conservation (Specially Protected Fauna) Notice 2018.* 

## CD Species of special conservation interest (conservation dependent fauna)

Fauna of special conservation need being species dependent on ongoing conservation intervention to prevent it becoming eligible for listing as threatened, and listing is otherwise in accordance with the ministerial guidelines (section 14 of the BC Act).

Published as conservation dependent fauna under schedule 6 of the *Wildlife Conservation (Specially Protected Fauna) Notice 2018.* 

### OS Other specially protected species

Fauna otherwise in need of special protection to ensure their conservation, and listing is otherwise in accordance with the ministerial guidelines (section 18 of the BC Act).

Published as other specially protected fauna under schedule 7 of the *Wildlife Conservation (Specially Protected Fauna) Notice 2018.* 

### P <u>Priority species:</u>

Possibly threatened species that do not meet survey criteria, or are otherwise data deficient, are added to the Priority Fauna or Priority Flora Lists under Priorities 1, 2 or 3. These three categories

are ranked in order of priority for survey and evaluation of conservation status so that consideration can be given to their declaration as threatened fauna or flora.

Species that are adequately known, are rare but not threatened, or meet criteria for near threatened, or that have been recently removed from the threatened species or other specially protected fauna lists for other than taxonomic reasons, are placed in Priority 4. These species require regular monitoring.

Assessment of Priority codes is based on the Western Australian distribution of the species, unless the distribution in WA is part of a contiguous population extending into adjacent States, as defined by the known spread of locations.

## P1 Priority One - Poorly-known species

Species that are known from one or a few locations (generally five or less) which are potentially at risk. All occurrences are either: very small; or on lands not managed for conservation, e.g. agricultural or pastoral lands, urban areas, road and rail reserves, gravel reserves and active mineral leases; or otherwise under threat of habitat destruction or degradation. Species may be included if they are comparatively well known from one or more locations but do not meet adequacy of survey requirements and appear to be under immediate threat from known threatening processes. Such species are in urgent need of further survey.

## P2 Priority Two - Poorly-known species

Species that are known from one or a few locations (generally five or less), some of which are on lands managed primarily for nature conservation, e.g. national parks, conservation parks, nature reserves and other lands with secure tenure being managed for conservation. Species may be included if they are comparatively well known from one or more locations but do not meet adequacy of survey requirements and appear to be under threat from known threatening processes. Such species are in urgent need of further survey.

## P3 Priority Three - Poorly-known species

Species that are known from several locations, and the species does not appear to be under imminent threat, or from few but widespread locations with either large population size or significant remaining areas of apparently suitable habitat, much of it not under imminent threat. Species may be included if they are comparatively well known from several locations but do not meet adequacy of survey requirements and known threatening processes exist that could affect them. Such species are in need of further survey.

### P4 Priority Four - Rare, Near Threatened and other species in need of monitoring

(a) Rare. Species that are considered to have been adequately surveyed, or for which sufficient knowledge is available, and that are considered not currently threatened or in need of special protection but could be if present circumstances change. These species are usually represented on conservation lands.

(b) Near Threatened. Species that are considered to have been adequately surveyed and that are close to qualifying for vulnerable but are not listed as Conservation Dependent.

(c) Species that have been removed from the list of threatened species during the past five years for reasons other than taxonomy.
