

CLEARING PERMIT

Granted under section 51E of the Environmental Protection Act 1986

Purpose Permit number: 9640/1

Duration of Permit: From 10 June 2023 to 9 June 2028

Permit Holder: Navigator Mining Pty Ltd

The Permit Holder is authorised to clear native vegetation subject to the following conditions of this Permit.

PART I - CLEARING AUTHORISED

1. Land on which clearing is to be done

2. Clearing authorised (purpose)

The Permit Holder is authorised to clear native vegetation for the purpose of mineral production and associated activities.

3. Area of Clearing




Figure 1: Map of the boundary of the area within which clearing may occur

The Permit Holder must not clear more than 355 hectares of native vegetation within the area cross-hatched in Figure 1 of Schedule 1.

4. Type of Clearing Authorised

The Permit Holder shall not clear native vegetation unless the purpose for which the clearing is authorised is enacted within 6 months of the authorised clearing being undertaken.

5. Direction of Clearing

The Permit Holder must conduct clearing activities in a slow, progressive manner into one direction to allow fauna to move into adjacent native vegetation ahead of the clearing activity.

PART II - MANAGEMENT CONDITIONS

6. Avoid, minimise and reduce the impacts and extent of clearing

In determining the amount of native vegetation to be cleared under this Permit, the Permit Holder must apply the following principles, set out in descending order of preference:

(a) avoid the clearing of native vegetation;

- (b) minimise the amount of native vegetation to be cleared; and
- (c) reduce the impact of clearing on any environmental value.

7. Weed control

When undertaking any clearing or other activity authorised under this Permit, the Permit Holder must take the following steps to minimise the risk of the introduction and spread of *weeds*:

- (a) clean earth-moving machinery of soil and vegetation prior to entering and leaving the area to be cleared;
- (b) ensure that no known weed-affected soil, mulch, fill or other material is brought into the area to be cleared; and
- (c) restrict the movement of machines and other vehicles to the limits of the areas to be cleared.

8. Vegetation Management

- (a) where practicable the Permit Holder shall avoid clearing riparian vegetation; and
- (b) where a *watercourse* or *drainage line* is to be impacted by clearing, the Permit Holder shall ensure that the existing surface flow is maintained, or reinstated downstream into existing natural *drainage lines*.

9. Flora Management

Where the *priority flora* species *Eremophila annosicaulis* and *Hibiscus* sp. Perrinvale Station have been identified and their written location(s), provided to the *CEO*, within the report 'Western Botanical (2019) Flora and Vegetation Assessment, Leonora Gold Project. Report prepared for Kin Mining Pty Ltd, June 2019', as retained on DMIRS file A0443/202201 as Doc ID 9053560, the Permit Holder shall ensure that:

- (a) no clearing of the identified *priority flora* species occurs, unless first approved by the CEO; and
- (b) no clearing occurs witin 10 metres of the identified *priority flora* species, unless first approved by the CEO.

PART III - RECORD KEEPING AND REPORTING

10. Records to be kept

The Permit Holder must maintain records relating to the listed relevant matters in accordance with the specifications detailed in Table 1.

2.	In relation to flora management pursuant to Condition 9	(a)	the name and location of each <i>priority flora</i> species, recorded using a Global Positioning System (GPS) unit set to Geocentric Datum Australia 1994 (GDA94), expressing the geographical coordinates in Eastings and Northings;
		(b)	actions taken to demarcate each <i>priority flora</i> species recorded and their relevant buffers; and
		(c)	actions taken to avoid the clearing of <i>priority flora</i> species.

11. Reporting

- (a) The Permit Holder shall provide a report to the *CEO* by 31 July each year for the life of this Permit, demonstrating adherence to all conditions of this Permit, and setting out the records required under Condition 10 of this Permit in relation to clearing carried out between 1 July and 30 June of the previous financial year.
- (b) If no clearing authorised under this Permit was undertaken between 1 July and 30 June of the previous financial year, a written report confirming that no clearing under this permit has been carried out, must be provided to the *CEO* by 31 July of each year.
- (c) Prior to 9 June 2028, the Permit Holder must provide to the *CEO* a written report of records required under Condition 10 of this Permit where these records have not already been provided under Condition 11(a) or 11(b) of this Permit.

DEFINITIONS

In this Permit, the terms in Table 2 have the meanings defined.

drainage line/s	means a natural depression that carries surface water runoff.

fill	means material used to increase the ground level, or to fill a depression.		
mulch	means the use of organic matter, wood chips or rocks to slow the movement of water across the soil surface and to reduce evaporation.		
native vegetation	has the meaning given under section 3(1) and section 51A of the EP Act.

The boundary of the area authorised to be cleared is shown in the map below (Figure 1).
