The clearing of native vegetation is prohibited in Western Australia unless a clearing permit has been granted for the clearing or where a permit is not required (either due to a referral determination that one is not needed or because an exemption applies). As such, species have been further defined to a morphological level and not identified as conservation significant <i>Idiosoma sp</i>. This amendment has been submitted to amend the pre-clearance fauna survey conditions specific to <i>Idiosoma sp</i>. based on this updated information.</p>
