## Application to amend a clearing permit

*Environmental Protection Act 1986, section 51KA*

### FORM C4

The clearing of native vegetation is prohibited in Western Australia unless a clearing permit has been granted for the clearing or where a permit is not required (either due to a referral determination that one is not needed or because an exemption applies). A person who causes or allows unauthorised clearing commits an offence.

#### Part 1: Assessment bilateral agreement

As such, species have been further defined to a morphological level and not identified as conservation significant <i>Idiosoma</i> sp. This amendment has been submitted to amend the pre-clearance fauna survey conditions specific to <i>Idiosoma</i> sp. based on this updated information.</p>
