| Provide the <br> avoidance and <br> mitigation <br> details | The ability to avoid impacts to the mangrove was heavily constrained by the <br> location of the existing seawall requiring refurbishment. The City sought advice <br> from DBCA regarding mitigation measures (see email attachment), who <br> suggested that the City divert the seawall inand from the mangrove, installing a <br> steel curtain on the landward side of the mangrove to protect it from the effects <br> of the dewatering. The City will do what we can, however technical and budget <br> limitations may mean it is not feasible to change the current design. |

| DBCA also stated that the plant and roots should be watered regularly to <br> increase the chance of survival. Therefore, mitigation measures include watering <br> within the root zone (during land-side dewatering practices). Pruning will be <br> undertaken by a suitably qualified person to ensure that the mangrove is not <br> over pruned and detrimentally impacted. |  |
